6.1. Recognition of Prior Learning

An RPL Application fee is payable at the time of submitting the application form, charged per nationally accredited unit.

Recognition of Prior Learning is assessed upon submission of W-Inst Form 005 RPL EOI Application Form.

The application fee is not refundable if RPL is not granted upon assessment of the application and evidence. The student's tuition fee is not reduced when RPL is granted.

6.2. Rescheduled Practical Session Fees

Many of our Courses include practical sessions including:

- i. Simulation Lab 1,
- ii. Simulation Lab 2,
- iii. Parking Practical Session,
- iv. Animal Handling Workshop,
- v. Investigations Practical Session, and
- vi. Presenting in Court practical Session.

The dates of these sessions are scheduled and confirmed in your Student Portal throughout your Course.

If you do not attend a practical session, and you haven't provided sufficient notice, you will be charged a "Rescheduling Practical Session Fee".

- i. We will not reschedule the session until this fee has been paid.
- ii. This may impact on your ability to complete your Course.

We understand that life can get in the way sometimes:

- i. If your schedule changes and you provide 14 days' notice, you will not be charged a fee.
- ii. If you are unwell, and provide a medical certificate, you will not be charged a fee.
- iii. If we reschedule your session, you will not be charged a fee.

6.3. Rescheduled Practical Placement Fee

Many of our Courses include a practical placement component. These placements are necessary in order to successfully complete your qualification.

If you do not attend your scheduled practical placement, and you haven't provided sufficient notice, you will be charged a "Rescheduling Practical Placement Fee".

- i. We will not reschedule your practical placement until this fee has been paid.
- ii. This may impact on your ability to complete your Course.

We understand that life can get in the way sometimes.

- i. If your schedule changes and you provide 14 days' notice, you will not be charged a fee.
- ii. If you are unwell, and provide a medical certificate, you will not be charged a fee.
- iii. If the Host Placement Provider cancels your placement, you will not be charged a fee. Generally, this would be due to an infectious illness outbreak, meaning that visitors are excluded from attending the facility.

6.4. Reissue of Certificates /Statement of Attainments

A reissue fee will apply to reissue any previously supplied Statement of Attainments or Testamur, charged per document.

Requests can be made directly to our Student Support Team via phone or email.

6.5. Student Transfer to another Class

A transfer is defined as when a student commences in their course and then wishes to transfer to a different class.

A transfer to another class is not encouraged for various reasons.

The decision to waive or reduce the transfer fee for students transferring to another class rests with the Manager Education Delivery & Student Success.

6.6. Student Recommencement after Withdrawal

Recommencement in the same calendar year as commencement

Where a student who has withdrawn from their course requests to restart the same qualification, within the same calendar year they commenced, this is a recommencement.

Applications for recommencement must be made in writing to the Course Consultant.

A recommencement fee will apply, and the materials fee applicable to that qualification may apply.

The decision to waive or reduce the student's recommencement fee rests with the Manager Education & Student Success.

Recommencement in a different year to commencement

Where a student who has withdrawn from their course requests to restart the same qualification, in a different calendar year to that when they commenced, they are not eligible for recommencement.

This is considered a new enrolment, and the student will undertake the full enrolment process.

Enrolment Application Fee, Materials Fee, and Tuition Fees: As current at time of application.

6.7. GST

GST is charged on all fees associated with the delivery of non-accredited training services.
