

Gawara Baya Social License Commitments under Capacity Investment Scheme Agreement (CISA)

The Gawara Baya Wind Farm has been awarded a Capacity Investment Scheme Agreement (CISA) by the Australian Government. This supports new clean energy generation and strengthens regional investment in skills, jobs and community partnerships in North Queensland.

The CISA allows Windlab to expand local training, workforce development and supply chain participation, helping the project deliver greater benefits sooner. The project is expected to create more than 300 jobs at peak construction, with strong local content requirements built into major contracts. It also includes dedicated First Nations partnerships focused on protecting cultural heritage, creating employment pathways and building long-term relationships with Traditional Owners.

In addition, Gawara Baya will provide a \$200,000 annual Community Benefit Fund, shared equally across the Hinchinbrook and Charters Towers local government areas, to support local health, liveability, economic development and environmental priorities.

The following tables outline the Social License Commitments and initiatives that Windlab has committed to and are included in the Gawara Baya Wind Farm CISA.
