Dear Chairman Garbarino and Ranking Member Thompson,

The undersigned trade associations (collectively, "the associations") urge Congress to pass the Widespread Information Management for the Welfare of Infrastructure and Government Act ("WIMWIG") before September 30, 2025. The legislation reauthorizes the foundational tenets of the Cybersecurity and Information Sharing Act of 2015 ("CISA 2015") for an additional ten years, while also accounting for important updates to the enacting legislation that address the evolving cybersecurity threat landscape.

Originally enacted in 2015 with broad bipartisan support, CISA 2015 established the voluntary information network to enable "public and private sector entities to share cyber threat information, removing legal barriers and the threat of unnecessary litigation." Of paramount importance, the law's antitrust exemption and liability protections enables private sector sharing of sensitive cyber information. These authorities are foundational to strengthening our collective defense against cybersecurity threats, facilitating trust in the public-private partnership, and serving as the backbone of essential programs across the federal government – programs that have measurably improved the security posture of critical infrastructure in the United States and strengthened the federal governments' security awareness.

WIMWIG ensures these fundamental principles are maintained, while including key updates that capture the evolution of the cybersecurity ecosystem over the last ten years.

In support of our national and energy security goals, the associations and the companies we represent thank you for your leadership on this issue and stand ready to engage with Congress to ensure WIMWIG is quickly enacted into law before the expiration of CISA 2015 on September 30, 2025.
