This rental offering consists of 36 quarter sections of grain land north of Lancer, totaling 5,698 ISC title acres with 5,052 cultivated acres, 290 pasture acres, and 345 other acres as per SAMA. Recent work on the farm includes removal of most tree rows, improving field efficiency, and the addition of six Westeel 3609 grain bins (approximately 31,030 bushels each) constructed in 2021 at the central yard site.

A strong opportunity for operators looking to add acres and increase scale in a productive farming area.

- **4.** Any crop unharvested or stored on the land may be harvested and removed from the land according to The Agricultural Leaseholds Act.
- 5. All offers must be received by the tender deadline 2 p.m. Wednesday, January 21, 2026.
- **6.** The Landlord acknowledges and accepts that the property manager WILL NOT inform or present the Landlord with any offers received until the TENDER has closed (date and time mention in term 5. Above).
- **7.** Bidder is responsible to familiarize themselves with the farmland prior to submitting a bid.
- **8.** The successful bidder must sign a formal Lease Agreement within 14 days of notification of the successful bid. Failure to enter into a Lease Agreement within the prescribed time will be deemed in default and will forfeit their rights to leasing the farmlands.

SAMA Information

This information is collected from Saskatchewan Assessment Management Agency via field sheets on each individual parcel. It includes specific information such as: assessed value, uses of soil (cultivated, arable, pasture, wetlands, etc), number of acres for each use, soil profile information including association & texture, topography, stones, salinity and soil final rating.

Soil Final Rating

The final rating (FR) is the productivity rating for the acres adjusted for economic factors that affect the average cost of production for specified features. The economic factors include stones, topography, natural hazards, man-made hazards, tree cover and miles to market. The final rating units are index points per acre. Soils are given a rating from 100 (best) to 0 (worst). Soils with a final rating under 30 are marginal and rarely cropped.

Saskatchewan Crop Insurance Corporation (SCIC)

SCIC gives a class rating to every quarter section in Saskatchewan to reflect its productivity. Ratings range from Class A (best) to Class P (worst). There are 23 different risk zones in Saskatchewan. Please note a class B rating in risk zone 3 does not necessarily have the same productive capacity as a class B rating in risk zone 16.
