#### **Approval of Minutes**

#### To Approve the Annual Meeting Minutes for August 15, 2024

Chairperson Larson stated that HHA Wilikina Apartments Project, Inc. (now known as Kawahi Maluwai) is a 119-unit low-income residential housing project which operates under the provisions of HUD's Section 8 Housing Assistance Payments Program. The project is located at 730 Wilikina Drive, Wahiawa, Oahu, Hawaii. In 2009, the Board of Directors of the HHA Wilikina Apartments Project, Inc. authorized property for leasehold sale. VB Wilikina Limited Partnership, a Washington limited partnership, purchased the property in "as is-where is and with all faults" condition without any warranties and guarantees and performed substantial renovations on the property financed with tax exempt bonds, low-income housing tax credits, and a seller reserve funds loan. In 2012, the HPHA entered into a 65-year ground lease agreement with the partnership.

#### **Election of Chairperson**

Chairperson Larson requested nominations for Chairperson for the HHA Wilikina Apartments Project, Inc.

Director Taniguchi nominated Director Betty Lou Larson as Chairperson. Director Larson accepted the nomination. Nominations were closed.
