Next up, we're highlighting NST's Jill of all Trades, keeping the clock ticking on upcoming CIP Standards, and making sure you're in the loop on this month's big events.

Quiz: Do you have what it takes to comply with CIP-012-2?

CIP-012-2 is on the way, with an **effective date of 7/21/26!** To help you prepare, we've put together a list of questions about your existing CIP-012-1 Plan to which you should be able to answer with a confident "Yes!". How do you score?

- Does your Plan identify all Real-time Assessment and Real-time monitoring data elements (TOP-003 & IRO-010)?
- 2. Does your Plan identify the circuits/pathways used to transmit data between Control Centers?
- 3. Does your Plan identify all communication segments, including alternate network paths, between each Control Center and the method of protection on each path segment?
- 4. Does your Plan identify the in-scope devices or procedures which implement the protections identified in R1.2 and R1.3?

- NST has worked with entities that have large numbers of encryption devices in their CIP-012 implementation. These devices are often not associated with a CIP BCS and not subject to CIP-002 thru CIP-011 protections, but compliance prudence would suggest the devices should be on a CIP-012 inventory list and a network diagram created to show the CC-to-CC communication pathways and protection points.
- 5. Does your Plan address logical and/or physical protections? Have you talked to your current carrier about how they keep you online?
 - Many entities simply reference their CIP-006 Plan and keep related equipment within a PSP, but if communication pathways reside outside of the PSP, there should be physical protections for that segment.
