

Safe and effective geriatric medication management involves much more than simply administering what the doctor ordered. Drugs used to treat both chronic and acute conditions in the elderly provide powerful benefits but also carry significant risk. Assisted living providers have an obligation to partner with the resident, their surrogate decision makers, the prescriber, and pharmacy staff to identify and minimize those risks. 


