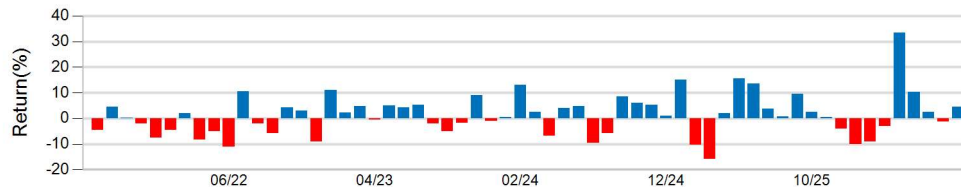

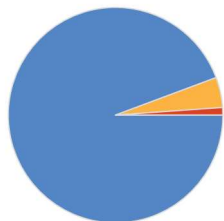

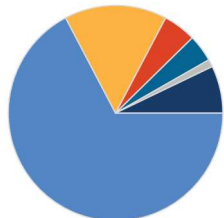

ASSET ALLOCATION (%)



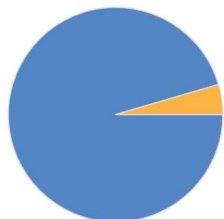

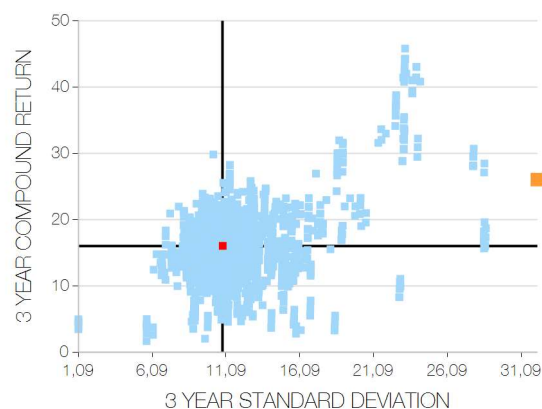
