LETTER FROM OUR PRESIDENT & CEO, MINDIE REULE

Where Community Becomes Connection

I am continually inspired by the generosity and commitment of the people who call the South Puget Sound home. This past year reminded me that when we come together with purpose, we can meet challenges, build understanding, and create meaningful change. At the Community Foundation, connection is central to our mission. It shapes how we bring people together, support local leadership, and move resources toward solutions shaped by the people who live here.

In 2025, that commitment came to life in meaningful ways. Through our inaugural Project Connect Grants, we supported local efforts that brought people together, built trust, and helped neighbors connect across differences. Our Community Conversation with Eric Liu invited people to reflect on their role in civic life and how to participate in shaping our communities. Give Local once again demonstrated the power of collective generosity, raising \$1.6 million for local nonprofits through gifts from more than 2,700 donors. Across this work, we saw what's possible when community is not just something we serve, but something we actively build.

At the same time, many in our region are navigating real challenges. Families are facing rising costs and uncertainty, and more people are turning to local nonprofits for support. Those organizations are experiencing increased demand, declining resources, and growing pressure on staff. In response, we are listening closely to what our communities need, continuing to provide flexible support, and helping grow the local giving needed to sustain this work.

Looking ahead, we remain committed to the work that matters most: strengthening connections across our communities, supporting more ways for people to care for and participate in community life, and growing the local generosity needed to support lasting change.

As I reflect on all we accomplished this year, I am filled with gratitude for the donors, nonprofit partners, volunteers, and community members who make this shared effort possible. Together, we are making more possible through connection, leadership, and investment—and through the belief that stronger communities are built when people have more ways to participate, contribute, and care for the places they call home.

Community Conversation

Community Conversations is one way the Community Foundation brings people together to exchange ideas, foster belonging, and strengthen the civic fabric of the South Sound. We are grateful to all who joined us—and all who continue to show that community is built through connection.

On May 20, 2025, more than 175 community members gathered at South Puget Sound Community College for this year's Community Conversation with Eric Liu—an evening rooted in connection, reflection, and shared purpose.

Through his remarks and a fireside chat with Renee Radcliff Sinclair, President & CEO of TVW, Liu invited us to see ourselves as active participants in civic life, with both the power and responsibility to shape their communities. Drawing on themes from his work, he emphasized that strengthening democracy begins with strengthening relationships—choosing connection over isolation and shared responsibility over division.

Following the program, participants engaged in a Q&A, reflecting on Liu's ideas and considering how they might take action in their own communities. These discussions created space to listen, learn, and build new connections—reinforcing that community is not something we inherit, but something we actively create together.

Meet Eric Liu!

Liu is the co-founder and CEO of Citizen University and the founding director of the Aspen Institute's Citizenship & American Identity Program. He is a contributing writer for *The Atlantic* and the author of several books, including *You're More Powerful Than You Think* and *Become America*.

"Our work at Citizen University feels urgent and meaningful, especially in this time when faith in democracy is declining, and civic know-how and civic cohesion are waning. Our team believes it's possible to spark a civic revival in this country. And we try to show it as much as say it—to find and connect and activate people all around our country who want to practice civic power and cultivate civic character to achieve true liberty and true justice truly for all."

First-place winners received a canvas print of their winning photo, and all winners were awarded a cash prize, with the option to donate their winnings as a grant to a nonprofit of their choice.

During our 9th Annual Give Local campaign, our community raised an impressive **\$1.6 million for 154 participating nonprofits**—making it our most successful year yet. We also saw increased community participation, with 100 individual fundraisers raising \$26,718.75 alongside nonprofit teams, helping boost awareness and engagement for the causes they care about.

This year also brought a **26% increase in unique donors**, reflecting growing enthusiasm and involvement across the region. Together, these acts of generosity strengthen the well-being of communities throughout Lewis, Mason, and Thurston counties, today and for the future.

2025 Scholarships

In 2025, the Community Foundation awarded 68 students a total of \$240,250 in scholarships, grounded in the belief that access to education strengthens the South Sound for generations to come.

Each year, the Foundation partners with high schools, youth-serving nonprofits, and scholarship donors to ensure students and families are aware of these opportunities. This year, we received 605 applications from 27 schools, reflecting growing awareness and the number of students seeking support for their educational goals.

Scholarship decisions are guided by community insight and care. In 2025, 34 volunteer reviewers contributed more than 250 hours, bringing their perspectives and lived experience to a thoughtful evaluation process that identifies the strongest match for each opportunity.

By investing in education, the Community Foundation helps students pursue their goals while strengthening our communities. We are grateful to all who make this work possible and celebrate the many accomplishments of this year's student scholars.

Student Spotlight: Atlas Gardner

Atlas graduates from Olympia High School with a 3.9 GPA and a passion for learning he hopes to pass on to future students. As a first generation college student, Atlas will attend Western Washington University to study Elementary Education. Inspired by teachers who supported him growing up, he hopes to create the same sense of encouragement and belonging in his own classroom. Through theater and stage management, Atlas also built confidence and discovered his voice—experiences that continue to shape his commitment to empathy, learning, and community care.



Student Spotlight: Keegan Clemons

Keegan graduates from North Thurston High School with a 3.68 GPA and a strong commitment to service. While completing a full Running Start course load, he balanced work, volunteer service, and caregiving for his grandfather. As a first-generation college student, Keegan will attend Saint Martin's University to study Criminal Justice with the goal of joining the Washington State Patrol. His experiences volunteering and supporting his family have strengthened his dedication to leadership, resilience, and serving his community.

Youth Mental Health Grants & Learning Cohort

Supporting young people takes strong, connected organizations. Through the Youth Mental Health Learning Cohort, local youth-serving partners built relationships, strengthened their practices, and turned shared learning into new collaborations.

In 2024, thirteen youth-serving organizations from Lewis, Mason, and Thurston counties came together for a year of shared learning, connection, and growth. Through monthly sessions, participants built skills in trauma-informed care, strengthened their own resilience, and formed relationships that continue to support their work.

Each organization received funding to support their participation—recognizing that time for learning and connection is essential, even when it can be difficult to step away from daily demands. As one participant shared, “These relationships have created meaningful opportunities to share resources and ideas.”

More than training, the cohort fostered a network grounded in trust—where participants could learn from one another, share resources, and build lasting connections. At the end of the cohort, participants had the opportunity to apply for additional funding to deepen their work together. These collaborative grants are supporting new approaches to youth mental health across the region in 2026.

The selected organizations represent the rich variety of youth programs across the South Sound. Their work ranges from essential basic needs to offering enrichment opportunities like outdoor education and dance programs. This range of services reflects what we know about youth well-being: young people need stable foundations and opportunities to grow and thrive.

Project Connect Grants

In 2025, the Community Foundation launched Project Connect, awarding \$55,300 to 19 local projects—each offering a unique approach to strengthening community.

Designed to support civic participation, belonging, and shared understanding, Project Connect invests in community-led efforts that bring people together—especially those who might not otherwise connect. From neighborhood gatherings to collaborative initiatives, these projects reflect the creativity and commitment of local people working to build stronger communities.

Interest in the program was strong, with 44 applications submitted and 30 advancing to review by a volunteer committee representing Lewis, Mason, and Thurston counties. As a pilot effort, Project Connect also provided valuable insights to help guide future grantmaking, including opportunities to expand participation and better align timelines with community-led activities.

As this first round concludes, we are inspired by the many ways people across the South Sound are creating space to listen, learn, and connect. Project Connect demonstrates that when neighbors come together around a shared purpose, meaningful change can begin locally.

Community Grants

Together with our communities, the Community Foundation awarded \$444,500 in Community Grants to 110 nonprofits, with individual awards ranging from \$2,000 to \$6,000 in flexible unrestricted funding.

This year brought both inspiration and challenge. We received more applications than ever before—a reflection of the extraordinary need facing local nonprofits as they respond to the loss of government funding and increasing community demand. While we were able to support many nonprofits, we also had to decline more applications than in any previous year. That reality weighs heavily on us and reinforces the vital role philanthropy plays in sustaining the services and programs that communities rely on every day.

Community Grants are awarded with the intention of providing two years of funding. The renewable two-year structure gives nonprofits more room to plan and focus more fully on their mission work. The grantmaking process itself reflects the power of collaboration, with 39 volunteer reviewers joining us in evaluating applications and shaping funding recommendations.

This year's grantees reflect the depth and diversity in the South Sound across missions and communities. Their work reaches people of all ages and backgrounds—connecting neighbors, nurturing young people, caring for elders, protecting our environment, and building pathways to opportunity. Each grant represents an investment not just in programs, but in people—and in the belief that our future is strongest when we work together and care for one another.

Meet the Grantees!

While we are celebrating 110 grantees (full list on the next page), we wanted to spotlight three to highlight the breadth of good work these Community Grants are funding.

Centralia Downtown Association (CDA)

Strengthening both the look and feel of downtown Centralia, the CDA helps keep the city's historic core vibrant, welcoming, and connected. Working alongside residents, merchants, and civic partners, CDA strengthens small businesses, enhances public spaces, and brings people together through cherished community traditions that build pride of place. While Roots: A Makers Collective and The Foundry offer mentorship and skill-building for emerging entrepreneurs. With support from Community Grants, CDA will continue blending preservation and innovation to nurture a downtown where people feel rooted, included, and invested in the community's future.



Mason County Senior Activities Association (MCSAA)

Serving as a welcoming hub for older adults, the Senior Activities Center helps community members stay active, connected, and supported through a wide range of social, educational, and wellness programs. As rising costs and social isolation continue to impact seniors, the Center has become a true lifeline, offering a friendly space for those who might otherwise be alone. MCSAA staff and board members are active participants in the Center, and their firsthand involvement ensures that programs remain relevant and inclusive to real needs. Though this grant, MCSAA will continue to provide opportunities that help older adults remain engaged, resilient, and connected.



Women's Dignity School (WDS)

Creating space for belonging, confidence, and leadership, WDS empowers immigrant, refugee, and marginalized women through education and community connection. Founded in Mali in 1998, WDS has equipped more than 31,000 women worldwide with literacy, vocational, and leadership skills—a legacy now expanding to rural Washington. Its first U.S. initiative, Lead With Dignity, is a community-based leadership program offering culturally rooted spaces where women gain confidence, share stories, and step into civic life. Grant support will help sustain these efforts and strengthen networks of belonging across the region.

Here's how we gave together in 2025

Grant Programs: \$643,250

Grants awarded to nonprofit organizations through Community Grants, Project Connect Grants, and Youth Mental Health Grants.

Give Local: \$1,611,433

Funds raised through our regional online giving campaign helping raise nonprofit visibility. Total includes donations processed through the Community Foundation, and Mightycause Charitable Foundation.

Scholarship Funds: \$245,166

Scholarship awards for students pursuing post-secondary education, including both new and renewable awards.

Agency & Designated Funds: \$1,547,969

Nonprofit, educational, or religious organizations establish Agency Funds to sustain their work. Donors establish designated funds to benefit specific nonprofit organizations.

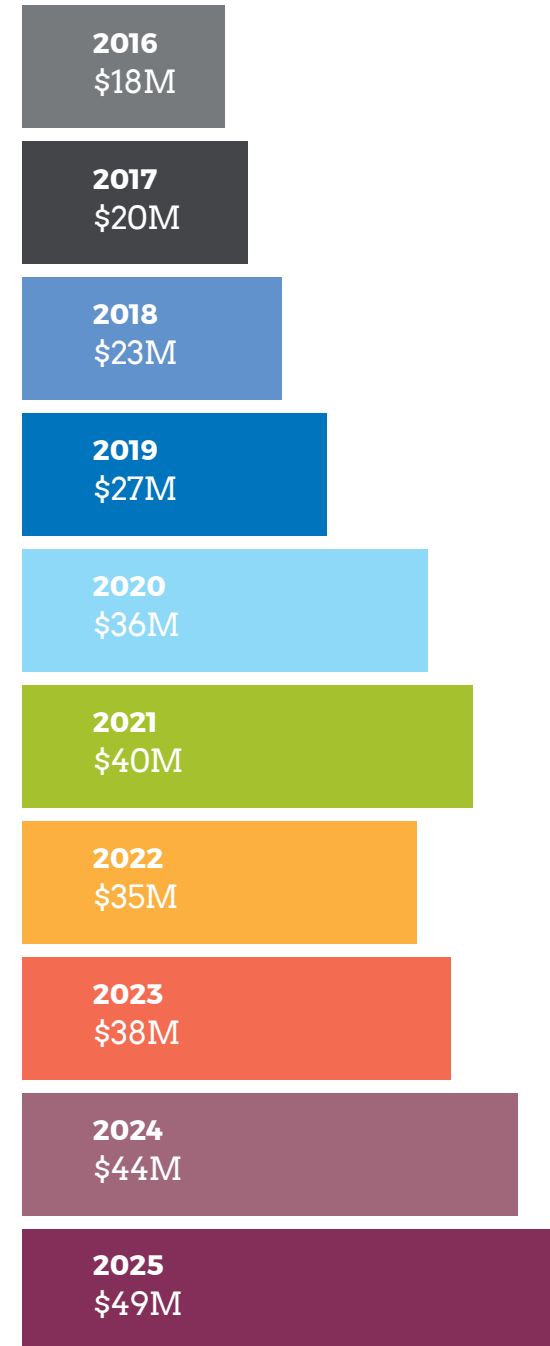
Donor Advised Funds: \$207,894

Grants awarded through field of interest funds, special project funds, and off-cycle funding opportunities.

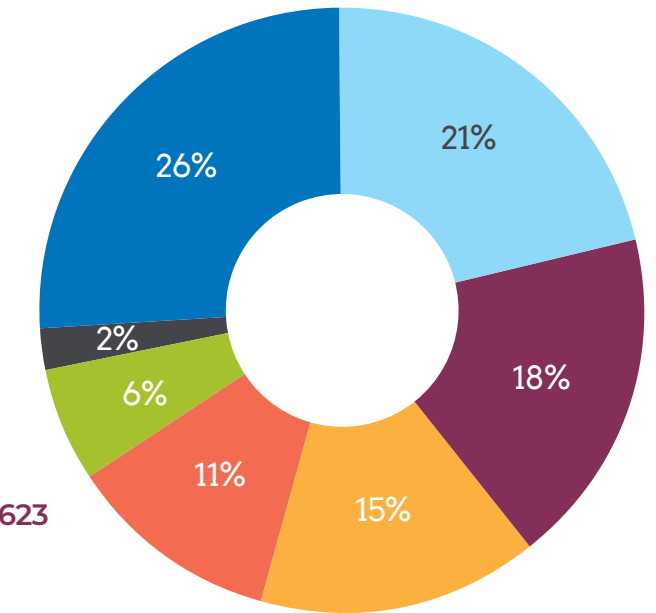

The State of South Sound Nonprofits

Nonprofits are essential to life in the South Sound, yet many are operating under growing strain. Demand for services is rising while resources remain limited. In a recent Community Foundation survey, 68% of local nonprofits reported increased demand in 2025, and many are facing staffing shortages, burnout, and difficult financial decisions.

These local challenges reflect broader national trends. Across the country, nonprofits report operating deficits, rising costs, and increasing pressure on staff. Many organizations are being asked to do more with less—while continuing to show up for their communities every day. As one nonprofit leader shared, “We’ve had to make layoffs while demand for our services keeps growing.”

For organizations that rely on government funding, shifting federal and state resources are adding new uncertainty. Across Lewis, Mason, and Thurston counties, nonprofits collectively receive millions in public funding to support essential services. Changes to these resources can have immediate and far-reaching impacts, particularly in areas like housing, food access, health care, and youth services.

At the same time, giving patterns are changing. Fewer individuals are giving overall, and charitable dollars are becoming more concentrated, leaving many small and mid-sized, community-based organizations with fewer options, even as demand grows.

Behind these trends are real people. Nonprofit teams are adapting to shifting conditions and assisting community members relying on these services for stability, care, and opportunity. The strain is real—but so is the commitment to continue showing up.

In response, the Community Foundation is working alongside partners to strengthen the nonprofit sector and the communities it serves. This includes investing in flexible, unrestricted funding, supporting capacity-building opportunities, convening partners to foster collaboration, and expanding initiatives like Give Local to grow community-wide giving.

We are also continuing to listen—through surveys, conversations, and partnerships—to better understand what nonprofits need now and what will sustain them in the future.

There are meaningful ways for everyone to be part of the response. Giving to local nonprofits, volunteering time, supporting local businesses, and sharing what you learn all help strengthen the network of care that supports our region.

This moment is challenging—but it is also an opportunity to come together, invest in what matters, and ensure our communities continue to thrive.

Fund Feature: Next Right Step Giving Circle



Building Community & Giving Together

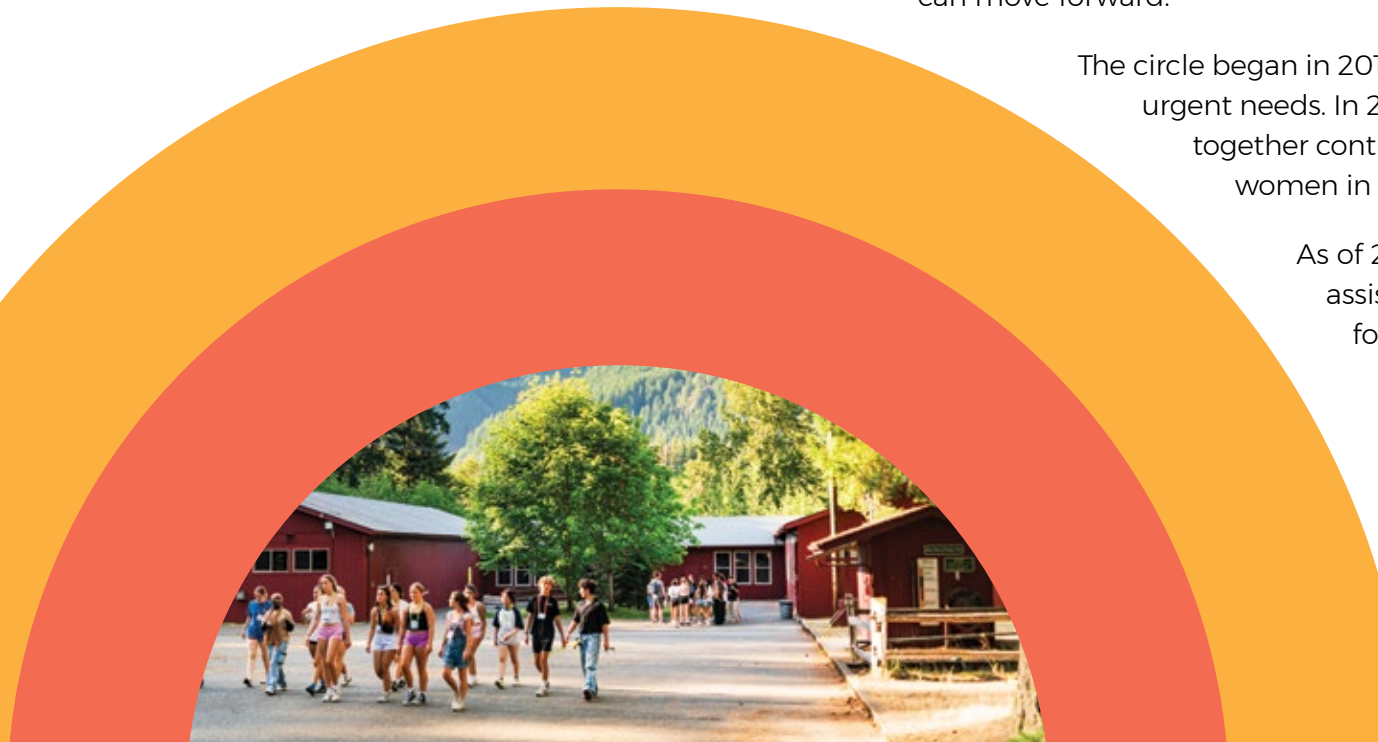
The Next Right Step Giving Circle (NRS) is a local example of collective giving—pooling resources to meet shared needs. While this approach has deep roots across cultures, it has gained renewed momentum as communities respond to growing challenges.

NRS shows how small acts of generosity can make a meaningful difference. Rooted in the idea that challenges can feel insurmountable without the right support, the circle helps “right-size” those moments—providing timely assistance so local women can move forward.

The circle began in 2016, when members of the Zonta Club of Olympia partnered with trusted nonprofits to meet urgent needs. In 2023, NRS became an independent giving circle at the Community Foundation, bringing together contributors, the Foundation, and Family Education and Support Services (FESS). Eligible women in Thurston County can apply for up to \$750 to cover essential expenses through FESS.

As of 2025, the circle has supported more than 330 women, providing over \$113,000 in assistance. As one participant, Maggie Hollinger, shared, “One time, all it took was a key fob”—a simple fix that restored a woman’s access to her car and her independence.

Beyond financial support, NRS fosters connection. Contributors gather quarterly to share meals, hear stories of impact, and build relationships—demonstrating how intentional connection strengthens community well-being. Annual contributions of \$1,000 support the circle’s grantmaking, and guests are always welcome. **Learn more at <https://sites.google.com/view/nrsgivingcircle/home> to get involved.**
