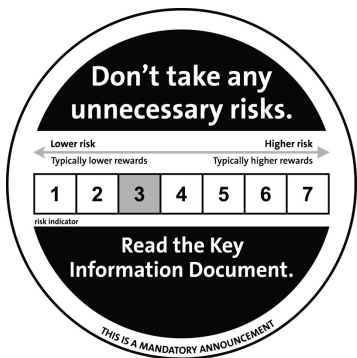

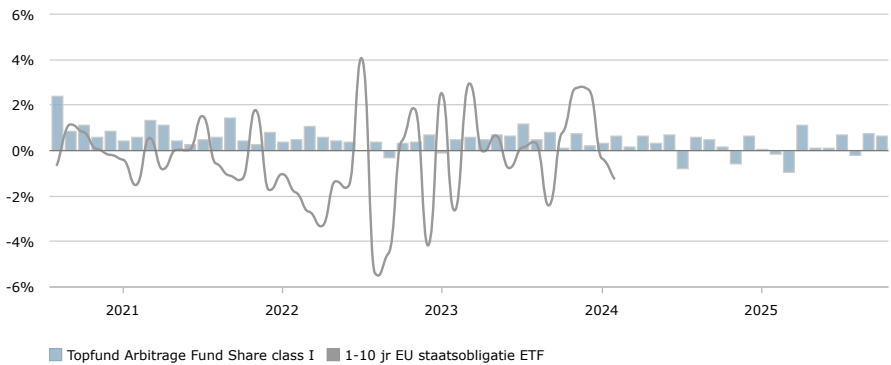

This is achieved by using multiple strategies that invest both long and short in EUR, USD, GBP, CAD, AUD, NZD, JPY and CHF. Our investment policy is characterised by moderate day-trading and is based on several strategies, applied in combination. In order to pursue the highest possible speed of trading, our trading platform is cross-connected to the server of our execution partner. Through the connection with the FX matching engine in our execution partner's Equinix LD4 network a routing latency of between 1 microsecond and 300 nanoseconds is ensured. 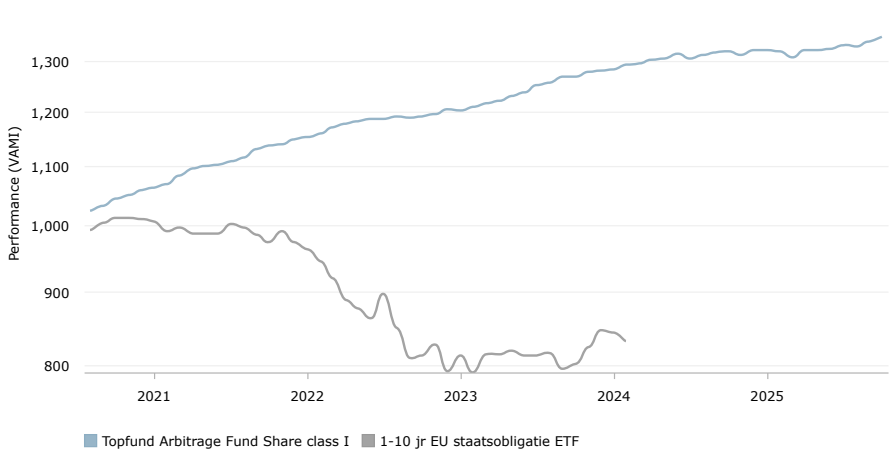
