# **Important Information**

#### **SOCIAL SECURITY**

If the deceased person has worked and paid into Social Security, some of the Social Security taxes paid are applied toward the survivor benefits. The amount of these benefits will be determined by Social Security. For answers to specific questions, contact the nearest Social Security Office. You may also contact them at www.ssa.gov or call (800) 772-1213 between the hours of 7 a.m. and 7 p.m. weekdays. The operator will need to know the deceased person's social security number, date of death and survivor's information.

#### **VETERANS ADMINISTRATION**

Honorably discharged veterans and their survivors may be eligible for a wide range of benefits. Information on a variety of topics may be obtained by contacting the nearest Veterans Administration office. You may also contact them at www.va.gov or call (800) 827-1000. For specific information about benefits, have the deceased person's VA number available for the benefits counselor when you call. Some of the benefits currently available to survivors of honorably discharged veterans include a burial flag, presidential memorial certificate, headstone or marker for the grave or niche of the veteran, and in some cases, burial allowances.

#### **PROBATE**

Simply stated, probate is the court process following a person's death that includes

- Proving the authenticity of the deceased person's will
- Appointing someone to handle the deceased person's affairs
- Identifying and inventorying the deceased person's property
- Paying debts and taxes
- Identifying heirs
- Distributing the deceased person's property according to the will or, if there is not will, according to state law.

#### LIFE INSURANCE

This is a contract in which an insurance company agrees to pay money to a designated beneficiary upon the death of the policyholder. In exchange, the policyholder pays a regularly scheduled fee, known as an insurance premium. The purpose of life insurance is to provide financial support to those who survive the policyholder. When the policyholder dies, the insurance proceeds pass to the beneficiary, free of probate, though they may be counted for federal estate tax purposes.

#### **DEATH CERTIFICATE**

You will need several copies of the death certificate for transferal of property, insurance, etc. The funeral home can obtain certified copies of the death certificate for you. The funeral home may charge a fee for the certified death certificates. Certified death certificates are required for Social Security, each life insurance company, stock market or money market accounts, pension plans, each bank, real estate, transferring title for automobiles, boats, etc. probate court and personal records.

# Celebrating a Life

As you are in the process of planning a Memorial/Celebration of Life service for your loved one, we extend our condolences for your loss.

Preparing for a Memorial/Celebration of Life service may take place some time later with more time for planning and preparation and for the distant and very busy family and friends to attend. It is worth considering if there are a great number of people who would like to attend or if you would like the service itself to be private.

Right now is a time of mixed emotions. Grief and sadness for sure, but it is also a hectic time. There is so much to think about in the planning of a service to remember a life shared and celebrated. We are providing this packet of information to help in the planning and celebrating of your loved one.

## **Memorial Follow Up**

The Memorial follow up is a critical step in providing care and support in the weeks after the Memorial/Celebration of Life service. People often receive a great deal of care and support immediately after a loved one dies. Within a few weeks, however the cards, letters, visits, and phone calls tend to taper off. Just when the reality of the loss is beginning to sink in, grieving people can find themselves feeling alone and forgotten.

Our Care Ministry team is committed to keeping in touch during the critical weeks and months after the loss of your loved one.

Our grief support includes a series of four books over the course of a year, to reach out with care at four crucial points during the grieving process, providing helpful, timely information while helping the person feel valued and remembered.

**Book 1** A Time to Grieve three weeks after the loss

**Book 2** Experiencing Grief three months after the loss

**Book 3** Finding Hope in Healing six months after the loss

**Book 4** Rebuilding and Remembering eleven months after the loss

Each book focuses on the feelings and issues a person is likely to be experiencing at that point in his or her grief, offering comfort, help and hope throughout that difficult year.

The Memorial Team will follow up with the family to see if they have received the books and to see how they are doing. It is recommended that the individual and/or family have engaged in Pastoral Care or counseling using the Grief resources provided in this packet.
