#### **Motions from the Budget and Financial Planning Committee**

(See following memo from CFO Kim Foster to the B&FP on February 8, 2022 detailing recommendations)

Motion was made to adopt the following six recommendations from the B&FP Committee:

- Transfer \$120,000 from the Mission Vitality Fund to the Episcopal Transition Fund
- Tranfer \$200,000 from the Mission Vitality Fund to the Rainy-Day Fund.
- Create a \$50,000 fund for Hispanic Ministry, coming from the Mission Vitality Fund.
- Designate the recurring \$5,000 annual distributions from the Elsa P. Stickney Trust for the benefit of "mainstream" Hispanic Ministry program costs as part of the Diocesan annual operating budget
- Transfer \$100,000 of excess cash from the Diocese's operating account to the Rainy-Day Fund.
- Transfer \$12,500 annually in excess cash generated through interest income from EMWM checking account to the Rainy-Day Fund.

The motion was made, seconded and passed unanimously.

The following motion was also recommended by the B&FP Committee to continue to build the Rainy-Day Fund:

- To add \$100,000 from excess cash in the Diocese's operating account to the Rainy-Day Fund as a result of the 2020 budget surplus.
- To add \$12,500 each year for the years 2023-2026 from excess cash in the EMWM account from interest earned on the mortgage in Worcester to the Rainy-Day Fund.

The motion was made, seconded and passed unanimously.

#### Merger of Trinity Church, Chicopee into Episcopal Missions of Western Massachusetts

Moved: To approve, endorse and adopt the Agreement for the Merger of Trinity Church of Chicopee, Massachusetts, with Episcopal Missions of Western Massachusetts.

# **SUMMARY:**

- The B&FP Committee met on February 8<sup>th</sup>, 2022 for the primary purpose of recommending to Council the repurposing of certain invested funds held by the Trustees for the Diocese.
- The goal and benefit of repurposing these funds (all on re-invest) is to assure we preserve the long-term, financial strength of the organization by safeguarding the balances of all other funds held by the Trustees for the Diocese in support of the 5% rule distribution.
- By repurposing now, we will assure funds are available where needed and we will not need to compromise the strength of our quarterly distributions in the future.

#### FACTORS CREATING FUTURE BUDGET CHALLENGES:

The committee discussed several factors contributing to budget challenges over the next several years and reviewed the costs associated with these factors. In summary, over the next five-years, we expect to request additional draws in excess of \$500,000 from invested funds to balance the annual operating budget. The factors contributing to annual deficits through 2026 are as follows:

- Rising cost of health insurance premiums (typically 5 6% each year, cumulative)
- Cumulative cost of living adjustments (COLA) sufficient to meet the rising level of inflation
- Staff transition expense for 4 5 key staff over the next five years
- Possible addition to staff composition
- Reduction in Common Ministry assessment income due to closed or merged congregations and/or declining operating income
- Potential reduction of Investment Income due to market fluctuations and/or corrections
- 2025 General Convention

# SPECIFIC MOTIONS MADE & CARRIED BY B&FP COMMITTEE, TUESDAY, FEB 8<sup>TH</sup>, 2022:

- 1. Transfer \$120,000 from the Mission Vitality Fund to the Episcopal Transition Fund.
- 2. Transfer \$200,000 from the Mission Vitality Fund to the Rainy-Day Fund.
- 3. Create a \$50,000 fund for Hispanic Ministry, coming from the Mission Vitality Fund.
- **4.** Designate the recurring **\$5,000** annual distributions from the Elsa P. Stickney Trust for the benefit of 'mainstream' Hispanic Ministry program costs as part of the Diocesan annual operating budget.
- **5.** Transfer **\$100,000** of excess cash from the Diocese's operating account to the Rainy-Day Fund.
- 6. Transfer \$12,500 annually in excess cash generated through interest income from EMWM checking account to the Rainy-Day Fund.

# ADDITIONAL CONTEXT IN SUPPORT OF MOTIONS MADE & CARRIED:

The B&FP Committee recommends we re-purpose approximately 42% (\$370,000) of the Mission Vitality Fund as follows:

- Add **\$120,000** to the Episcopal Transition Fund to assure we have ample funds to draw on when the time comes to support the Bishop's transition. This will give \$177,000 to work with and is comparable to the budget used for the prior transition.
- Add \$200,000 to the Rainy-Day Fund to assure the Diocese is equipped with designated funds needed to balance the operating budget each year and to cover the rising cost of health insurance, COLA increases and to support the many staff transitions (4-5) we are faced with over the next several years.
- Create a **\$50,000** fund for Hispanic Ministry, coming from the Mission Vitality Fund. In addition to this lump sum, the Elsa P. Stickney Trust will generate recurring distributions of \$5,000 each year beginning in 2023. The Committee proposes the recurring distribution be earmarked to cover 'mainstream' Hispanic Ministry program costs as part of the Diocesan annual operating budget.
- \$500,000 will remain in the Mission Vitality Fund in support of Human to Human in 2022 and beyond. NOTE: Over a four-year period (2018 2021), the Diocese has drawn on nearly \$800,000 of invested funds in support of Human to Human. We expect another \$220,000 will be applied in 2022 to balance the budget, for a total of over \$1M drawn from invested funds over five years.

In addition to the above repurposing of the Mission Vitality Fund, the B&FP Committee recommends we continue to build the Rainy-Day Fund as follows:

- Add **\$100,000** from excess cash in the Diocese's operating account, a result of the 2020 surplus.
- Add **\$12,500** each year (2023-2026) from excess cash in the EMWM account from interest income earned on the mortgage in Worcester.

# **Report on Transitions from Rich Simpson**

Rich noted the upcoming national gathering of Transition Ministers in March, at which he'll be presenting two parishes (St. Mark's, Leominister and St. Paul's, Holyoke). He also noted the upcoming retirements of two clergy, Nancy Webb Stroud from Atonement in Westfield and Laura Goodwin from

Holy Spirit in Sutton. Finally, he reported that he would be taking sabbatical from May through July of this year.

There was brief conversation about the upcoming February retreat and the need to change the format from in-person to Zoom due to the current Covid situation.
