### **Consent Agenda**

The Consent Agenda was moved, seconded and passed unanimously.

### Bishop's Time

The Bishop:

- Noted the prevelance of parishes collaborating with social service agencies in our towns and cities; especially in areas of food insecurity and work with seniors and immigrants.
- Announced the formation of a committee to explore our common mission across the Commonwealth. We're already doing good things in partnership with the Diocese of Massachusetts including working together on Episcopal City Mission, clergy retreats, collaboration with Bishops Alan Gates and Gayle Harris in issuing pastoral responses to Covid, etc. A team has been put together to explore what else we may do together. From Western Mass, the team includes Mark Rogers, Heather Blais, Nathaniel Anderson, Trudy Miller and Rich Simpson.
- We have directed \$6,000 to the Diocese of Mampong (Ghana) \$3,000 for the Babies Home and \$3000 for operating purposes.
- Noted the recent change by the SEC regarding rules around investing, which are affecting the Church's efforts in socially responsible investing. Unfortunately, the new rules dictate that the minimum investment to qualify for voice and vote as a shareholder has gone from \$2,000 held

for one year to \$15,000 held for five years, and the threshold for being able to put forward a resolution used to be 5%, which has now been raised to 35%. These new provisions will be fought in court, but are a blow to activist efforts to hold companies responsible. Holdings (such as ours in Smith & Wesson) in place are grandfathered in until 2022.

- Thanked Heather Blais and Donna Christian for their service, wisdom and guidance as they
  rotate off of Council.
- Shared his excitement over the response from the Diocese to various initiatives in lay ministry:
   40 people signed up to learn how to lead Morning Prayer; 12 signed up initially for Rich's course on lay preaching, and 26 signed up for Loving the Questions.

### 2021 Budget

The budget, which has been approved by the Budget and Financial Planning Committee as presented was moved and seconded.

Discussion: Steve noted that we will have to be nimble with our budgeting as assessment income will be a variable figure, and wise about our policy of reviewing assessment reduction requests. We did not change the formula for assessments this year. Investment income is expected to be pretty stable. Expenses were budgeted at the same as 2020 except for event and travel expenses. There are many unknowns. Budget assumes that assessments will be paid in full. The budget is balanced. We'll be watching to see if congregations need assistance.

The budget was unanimously approved to be forwarded to Convention for passage as presented.

### **Convention 2020 preview**

Planning for an entirely virtual Convention has been an exercise in flexibility. There are events planned throughout the week ahead of Convention, beginning with prayers for the general election on Monday evening, a budget hearing on Wednesday evening, a pre-convention meeting on Thursday evening, and Saturday morning worship followed by a lean, stripped-down business meeting that will conclude by noon. The planning team and staff have worked together to create a creative, responsive new version of Convention; some of which will provide useful ways to approach Convention in the future.

### Admission of a new mission: Hispanic Ministry in Worcester

The Hispanic Ministry in Worcester has been working for a year to take the steps to be admitted, including raising up leaders, etc., as a new mission of the Diocese. The ministry has also been reaching out across the Diocese to encourage other Hispanic Ministries, and has, for instance, been working with a community in Holyoke.

## Notes on the 3rnd Quarter 2020 Income Statement of the Administrative Offices of the Diocese of Western MA

### **Summary**

The Summary Statement of Diocesan Operations (based on actual assessments received) shows that we are ahead of budget as of the end of the third quarter by \$17K with a deficit YTD of \$7600. We believe we are still on track to break even at the end the year, based on the original budget.

The more detailed statements included entries related to the PPP loan, which will be discussed at the meeting.

### Revenue

- Revenues from assessments are off by \$138K due to the forgiveness that was granted at the beginning of the pandemic.
- Investment income is down approx. \$20K YTD.
- Those two items comprise all of the variance from the original budget

### **Bishop's Ministry**

• We were under budget in this category by \$17K. This is the result of diminished travel expenses and a reduction from projection in health insurance costs.

### **Congregational Development: Mission with Congregations**

- We were under budget by \$92K against projected expenses of \$439K.
- \$10K in grants given for Ministry Development Initiative grants was returned and the \$70K budgeted is not being used this year.
- Other unspent grant lines for small items comprise the balance of the variance.

### Formation and Leadership Development for the Baptized

- This category shows expenses under budget by \$76K on a budget of \$223K.
- We contributed \$10K to Lawrence House (unbudgeted expense)
- Parish Leadership Day was cancelled and expenses are \$7500 under budget.
- The clergy conference expense is under budget by \$10K.
- The budget for Strategic Leadership Development is \$10K under budget so far.
- Senior staff personnel changes earlier this year resulted in reduced payroll expenses of \$64,000

### Mission with the Larger Church/World

• This category is on target with a YTD budget of \$413K.

### Governance

- This category is on target with a YTD budget of \$1169K
- We incurred \$19K in unbudgeted expenses related to Title IV work on matters of clergy discipline.

### **Administration and Finance**

• This area of the budget is \$5000 over the YTD budget of \$356K.

### **Parish Payroll and Benefits Administration**

• Expenses are in line with the YTD budget of \$111K.

### **EMWM Real Estate Update**

November 23, 2020

<u>Blackinton</u>- We have taken the legal steps with the court necessary to clear the title on this property and are moving towards closing on the sale. Our petition will be ruled on in land court on January 5 after which we can close.

### St. Thomas, Auburn church building-

We are expecting to close on this transaction before year end. The congregation has reverted to mission status and is merging with EMWM as it will be selling its remaining real assets. They will pay EMWM \$25K out of sale proceeds plus expenses for the marketing work. The congregation has moved to the church in Oxford and will work as partners in ministry as they explore the potential future together.

### St. Luke's Old Stone Chapel in Lanesboro-

- The Diocese owns the property since St. Luke's, Lanesboro is a mission congregation, but St. Luke's has assumed full responsibility for the building forever, as far as I know. This building replaced the original church but the town center moved and the congregation built their current church in the new location and kept the stone church for use as a summer chapel. The diocese has no use for this building. Area churches are not looking to use it as a chapel, and the town is not interested in owning it.
- The chapel is in incredibly good shape on the inside, but the roof and windows are going to need to be repaired. They are slowly degrading to the point where weather will be an issue at some point. This is somewhere around a \$200K expense. It contains an historic pump organ.
- The building is subject to a Mass Historical Commission preservation restriction because we rec'd preservation grants in the 80s and 90s. There is an easement on the building to MHC which gives them the right to make sure the owners maintain the building.
- Frank has been in touch with MHC and we have learned that the restrictions are very limiting
  and MHC does not lift restriction. Part of the agreement is that the building shall be maintained.
  MHC has been told that the congregation is responsible for the property and they have run out
  of people and money to do this. We don't know what the MHC's enforcement capacity is. Don
  and Frank will try to learn the nature of our obligation to understand if it runs with the land.
- We had a buyer ready to go but his plans to renovate aren't allowed under the MHC contract. That deal has been terminated.
- A new buyer has emerged. We are not certain if this will lead to a sale because of the easements. Here's the story as I've heard it: Private buyer with money whose family runs a B and B nearby. They have made an offer (\$159K) which we have accepted. They want to maintain the building as it is and make it part of the experience of visiting the B and B. The buyer is seeking a mortgage and we are concerned about how a lender will handle the MHC easement.
