The Consent Agenda, which included Minutes from the November 21, 2019 meeting, the Financial Reports through November 2019, and the Real Estate Update were moved, seconded and unanimously approved.

Vote to Approve Operating Agreement Between Church of the Epiphany, Wilbraham and Christ the King Lutheran Church in Wilbraham

The agreement was moved, and seconded as presented. There was no discussion. It was passed unanimously on voice vote.

Vote to Approve Operating Agreement and Articles of Merger between Christ Church Episcopal, and Trinity Lutheran Church in Sheffield

The agreement was moved, and seconded as presented. There was no discussion. It was passed unanimously on voice vote.

Vote to affirm the request to reclassify St. Thomas, Auburn as a Mission Congregation

The request was moved and seconded. There was some discussion of the circumstances around this request. The rectory did not sell as quickly as planned. Conversations are ensuing with congregations in Rochdale and Oxford, but this situation, which is fluid, had been a long decline, and then a more sudden

financial emergency that progressed more rapidly than expected, forcing this decsion. The motion was passed unanimously on a voice vote.

Nancy Stoud, Steve Abdow and Dick Delorme raised for discussion the possibility that we may, in the future, get an Assessment Reduction Request from St. John's, Northampton. Council had some conversation around how we might want to approach requests like this from parishes with healthy endowments, but a sizable deficit. There was agreement that it's an opportunity to consider a variety of tools (loan, non-financial remediation, etc.), and to help the parish implement remedial measures. Discussion will be ongoing.

2:05 Called to order

Report on behalf of the Trustees – Mick Kalber

Mick presented an update on the Diocese's investment funds in the context of the current economic instability and the COVID-19 pandemic. He indicated that the precipitous market drops would be muted in distributions by the fact that the disbributions are based on a 20-quarter rolling average. The December fund value was approximately \$65 million; in the week before the meeting, the value was approximately \$55 million. However, Mick is encouraged that some assets had declined less than anticipated. Mick is continuing to meet with Mercer, our investment advisors and the Trustees to determine the wisest strategy under the circumstances.

Parish Relief Actions

Council reviewed the measures passed by Bishop's Budget and Finance Committee. The intent of the collection of measures is to make \$1 million in relief available for parishes struggling with the sudden economic downturn.

The first measure for approval by Council is forgiveness of two months of assessment payments: **Motion:** That the Council approve the foregiveness of Common Ministry Assessment payments from parishes for April and May.

Moved and seconded. There was discussion around the details of the program. The Bishop indicated that he is looking for an action that will help to allay anxiety now. There is recognition that this is not a long term solution, and further forgiveness may not be possible.

The motion was passed unanimously on a voice vote.

Parishes will be notified immediately of the assessment forgiveness by emailed message being drafted by Steve.

Further measures continue to be under discussion. Options include a loan pool of up to \$800,000. Concerns are to help parishes make payroll. There also recognition that the sharp spike in layoffs due to the pandemic response means that many in our parishes may be undergoing financial strain. Implications of the current situation will not be entirely know for some time.

Motion: To approve a draw of up to \$500,000 on the Diocesan line of credit at United Bank for the purpose of parish relief.

Moved and seconded. Discussion was around the plans for repayment, which will be from investments (at a presumably more advantageous time), budget reductions, repayments from parishes, etc. The motion was passed unanimously on a voice vote.

The meeting was adjourned at 3:10 p.m.

Financial Support and Potential Actions During This Time

Diocesan Council voted to suspend the collection of Common Ministry assessments for a period of two months. Assessment payments for April and May have been forgiven. We will cancel those two scheduled EFT withdrawals.

If your congregation is making ends meet and you are able to continue supporting our Common Ministry we will gratefully accept all or some portion of your assessment. Your contributions will be used to support other congregations. You may send a check, if this feels right. Regardless, we offer this suspension to enable you to continue God's mission locally.

We are urgently investigating options for financial support for our congregations available through the **Coronavirus Aid, Relief, and Economic Security (CARES) Act**. You will hear from us as soon as we reach some conclusions.

Church Insurance will be extending payments for 90 days beyond the effective/due date before cancellation. You may receive system generated notices during the extension. Please call the Church Insurance billing department at 1-800-819-2984 if you have any questions or receive a notice.

The Episcopal Church Medical Trust is providing a 90-day extension on employee benefit premiums for health insurance.

The Church Pension Fund is providing the same extension on pension assessments.

We encourage you to ask the members of your congregation to continue to financially support their church to the extent they are able, especially those among us who have pledged support for this year.

You will need to encourage **remote giving** which can take place in three ways:

- 1. Members mail their pledge payment to the church office
- 2. Schedule automatic payments through your bank's online banking service (recurring payments are the most reliable and helpful way to fulfill your pledge)
- 3. Provide online giving capability on your website through an established giving platform for either one time or recurring giving.

A recommended online giving platform is Tithely. They offer a discounted to members of The Episcopal Network for Stewardship of which all congregations of the diocese are members. They provide excellent support as a rule. There is no additional fee at all and you can get set up very quickly.

The TENS rate for credit card transactions is 2.75%+30c per transaction. Normally they are 2.9%+30c. https://get.tithe.ly/partner/tens.

Here is a copy of the letter that **Mick Kalber, Executive Director of the Trustees for the Diocese** sent out a week ago:

Hello Everyone,

In these uncertain and troubling times, I am passing along some information to you and your congregations regarding your Trustees funds.

As you recall, the Trustees' spending policy calculates its quarterly disbursement based upon the average ending market value of the Fund over the past 20 quarters. The relatively good news is that the 1Q 2020 ending market value, while expected to be dramatically lower, will be largely offset by the previous 19 ending market values. Thus, the disbursements you will receive the end of April are expected to be only about 1% lower than the disbursements you received last January. I want to allay your concerns of a dramatic reduction of your 1Q 2020 disbursements.

Diocesan House closed today for the foreseeable future, with only some members of the staff coming in occasionally to perform tasks they cannot do remotely. Thus, to expedite any Trustees requests you may submit, please communicate electronically – not using the U.S. Postal Service. I am working remotely and will respond to emails and voice mails: mkalber@diocesewma.org / 413-417-2339.

Here are a few ideas about other ways to manage cash flow:

OPERATIIONS

- Make sure the thermostats are reduced to be consistent with the reduced occupancy of the building. Consider turning off the furnace/hot water heater when it is warm enough and usage allows.
- Make sure the building is buttoned up windows, doors.
- Minimize electrical usage turn off all lights, unplug appliances.
- Revise cleaning intervals consistent with space usage

ADMINISTRATIVE/FINANCIAL

- See if you can preserve cash by changing utilities payments to budget plan
- Consider if any changes need to be made in the arrangements allowing creditors to withdraw amounts from your checking account without further authorization.
