The Rev. Heather Blais led the opening prayer and offered some ponderings for a healthy church this Easter season.

# <u>Group Discussion – Challenges for a 21<sup>st</sup> Century Congregation – Pam Mott (Appendix A, 1-6)</u>

Pam Mott started discussion, based on 1) assigned homework 2) a quote and 3) three questions. Committee then separated in different groups for discussion.

- "If we stay on the road we are on, surely we will get where we are going."
- Where in the statistics is the information for choosing another road seeds of renewal?
- What hit home in experiences in your own congregations?
- What are you going to do about it personally to choose another road?

Following small group discussion, these were the topics:

- Needing a sense of purpose
- Changing format and styles of worship / non- typical services
- Rotating lay leadership
- Church statistics do not match actual neighborhoods / aging congregations

- Ministries need to be for population that we're living with
- Do what you do well
- Worshipping with others
- Welcome our neighbors in and find out who they are
- Always an opportunity to grow
- Let dying things die / honor it and let it go
- Try more positive and fun things
- Want to move to new life
- What are our expressions of the gospel/ what would that look like?
- Church is not just going to church, what other things can we do to expand the idea of what church is?
- Using only one model is not a true measurement of effectiveness Bishop Fisher invited anyone who is interested in putting together an "Expressions of the Gospel Report" please email him to talk about it.

# Bishop's Time - Case Study (Appendix B):

Bishop started off discussion asking what other questions do we need to ask to form a decision?

- What is their approach to stewardship? Every September a letter goes out to them.
- What is the possibility of bringing in retired clergy?
- Are alternative ways thought of before approaching council?
- What is the relation with the neighboring Episcopal church? Is this church healthy?
- Nearby Lutheran congregation, but struggling also.
- Is the town growing?
- Relationship with Diocese?
- Do they participate in Diocesan events?
- What can be done to help the leadership?
- What would be missed if the church were to close?
- If we were starting over, would we put a church in that location?
- How many families/children?
- Would you use the same leadership if you were planting a new church?
- Consequences of growing a small congregation?
- Can the building be used for other purposes to generate income?
- What are they talking about in the parking lot?
- What are the demographics, income, race...etc.?
- What is their mission? What are they passionate about? What do they do well?

What is the capacity of the membership?

- Are they willing to do anything to grow?
- What about restarting a new church using a new model?
- What is the Diocese vision for this area?

Bishop's response to discussion and questions

- What are those criteria that we want?
- Decide to double down and pay for a full time clergy?
- This is worth the risk.
- Could this be a missed opportunity?
- Need to make sure the right person is in place to lead.

Bishop and Pam spent 24 hours with the Lutherans discussing how to work together.

- Three situations:
  - o Christ Church Trinity in Sheffield is working with the Methodists to select a rector
  - Church of the Epiphany in Wilbraham is working with a Lutheran Parish. They are trying to decide which building to sell.
  - Good Shephard Church in West Springfield is working with a small Lutheran Congregation. This is still in the "nesting" phase.

Meeting with UCC to discuss success stories:

- What would happen if worship was done in the same building, but at different times?
- Have coffee hour, and other functions together.

Pilgrimage on the Connecticut River, stopping each night and having prayer groups

There is a new Rabbi-in-Residence: Rabbi Mark Shapiro

• Bishop and Rabbi will teach a class together 4x a year regarding lectionary.
