

SPONSORSHIP FORM

1. This Agreement shall be binding upon its acceptance as set forth on Page 1 per the terms listed below.
2. The (“Sponsor”) hereby submits the signed Agreement (“Agreement”) for Sponsorship at the Geosteering World Cup which will be held on September 22, 2026, on-line.
3. Sponsorships are non-refundable and non-transferable.
4. All Sponsorships amounts are listed in U.S. dollars and must be paid in U.S. dollars.
5. Sponsorship monies paid to ROGII may be deductible as ordinary and necessary business expenses. They are not deductible as contributions or gifts for U.S. Federal income tax purposes.
6. Sponsorship fulfillment cannot be guaranteed unless the Sponsorship is fully paid. All sponsorships must be fully paid by August 28, 2026.
7. Sponsors hereby grant ROGII a nonexclusive license to use the Sponsor Brand only in connection with advertising and promotion of the Geosteering World Cup. Any use of the Sponsor Brand shall be carried out pursuant to the instructions of the Sponsor and ROGII shall be fully responsible for the fulfillment of these provisions. At the end of the Geosteering World Cup, ROGII must return or destroy, as appropriate, the materials including Sponsor Brand, and refrain from using them, unless authorized by Sponsor. None of the statements in this Agreement constitute the assignment or transfer of any intellectual or industrial property rights held by the Sponsor.

All actions arising out of or in connection with this Agreement shall be brought in the Harris County District Court, Houston, TX USA, and shall be exclusive forum therefor. The parties hereto hereby irrevocably submit to the inperson jurisdiction and process of the Harris County District Court, Houston, TX United States of America, and agree that service by certified mail to their addresses shall constitute sufficient service of process.
