#### Information Collection and Use

#### **Email Database**

The London Buddhist Centre holds a simple database used to send infrequent emails, for example:

- Information about upcoming events
- Fundraising for specific projects
- Volunteer or job opportunities

We will only email you if:

- You have given us your consent, or
- You have given permission to a third party to share data with us

You can unsubscribe at any time by contacting us.

#### **Email Communication Management System**

We use **MailChimp** as our email communication/marketing automation platform. By remaining on our membership database, you acknowledge that:

 Your information will be transferred to MailChimp for processing in accordance with their Privacy Policy and Terms.

#### **How We Use Your Information**

Everyone who comes on an event at the London Buddhist Centre is required to fill in a booking form. We require this information in order to contact you and manage the event.

- Your information is regarded as confidential and only shared with team members as necessary.
- In order to ensure the safety and wellbeing of all participants, we may create and retain records about incidents or problematic behaviour on courses, retreats and classes. These records may include your name, contact details, and a description of the incident.
- We normally retain such records for up to 15 years, as participants sometimes return to retreats, courses or classes many years later. However, we review these records every 5 years to check whether they are still relevant and necessary. Where a record is no longer required, it will be securely deleted sooner.

We will only use your information where we have a legal basis to do so and will always respect your rights. This includes:

- When you have **consented**
- When we have a legitimate interest, such as managing ongoing relationships with members and friends of the Triratna Buddhist Community, and to ensure the safety and well-being of yourself and others

We may also analyze geographic, demographic and other information to:

- Better understand your interests and preferences
- Contact you with the most relevant communications

This may include additional information from third-party sources when available.

#### **Examples of Data Use:**

- To respond to or fulfill any requests, complaints or queries you make to us
- To provide you with information and support for events, fundraising activities or volunteering opportunities you sign up to
- To send you publicity communications by email (if you have consented)

- To ensure the safety and well-being of yourself and others
- To manage your contact preferences

#### **Use of Cookies**

LondonBuddhistCentre.com uses cookies to:

- Store visitor preferences
- Record session information

This data is solely used to:

- Manage the website
- Track usage
- Improve website services

Cookies do not identify the user personally.

#### **Data Hosting:**

Our website is hosted on a server located in the **United States**, which means your data may be transferred outside the **EEA**. However, we are satisfied that appropriate safeguards are in place, including compliance with the **EU-US Privacy Shield** framework.

We will only share your data in other circumstances with your **explicit and informed consent**.
