I. PURPOSE

The purpose of this document is to provide standing orders for the provision of immunizations by clinical staff who are credentialed and privileged under their position description to do so in the absence of an order from the medical provider.

II. STANDING ORDER

Carolina Family Health Centers, Inc. (CFHC, Inc.) adheres to the Centers for Disease Control and Prevention's (CDC's) standing order templates for vaccine administration to its patient population. These templates offer comprehensive guidelines and detailed information for each vaccine and will serve as CFHC, Inc.'s standing order for the provision of immunizations. Clinical staff (nurses and certified medical assistants) are authorized to provide the vaccinations listed below to patients without an order from the medical provider when these order templates are followed. Staff are responsible for the documentation of the provision of the vaccines in the electronic health record system, as trained, and will ensure that quality controls and inventory practices are maintained.
