## Free school meals (FSM) and pupil premium funding

Pupils in reception, year 1 and year 2 all receive free school meals, paid by government funding. However, if your child is eligible for separate funding called 'Free School Meals', we still really want you to register - see why below. This will ensure your child receives a free school meal in subsequent school years, too (Year 3 and onwards).

### Why register for free school meals?

Children who are registered for free school meals don't have to eat them if you prefer them to have packed lunches, but registering them is still important because for every child registered for free school meals, the school gets an extra £1,515 (in 2025/26) through 'pupil premium' funding. Every child registered for free school meals makes a big difference to the school because we use it to improve the educational provision, experiences and resources available at school.

Please note, we do not receive this funding automatically. Parents must register their child(ren). Detailed information on the pupil premium can be found here: Pupil premium - GOV.UK (www.gov.uk)

#### Is my child eligible for free school meals?

You can register your child for Free School Meals, at any time, if you receive any of these benefits:

- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- The guaranteed element of State Pension Credit
- Child Tax Credit, provided you are not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190
- Working Tax Credit 'run-on' the payment someone may receive for a further four weeks after they stop qualifying for Working Tax Credit
- Universal Credit (provided you have an annual net earned income not exceeding £7,400

Please note you are not eligible if you are in receipt of Working Tax Credit.



















# How do I register?

Registering is really quick and easy. You only need to register once.

Registering will not affect any other benefits you are claiming.
