We offer it in two ways – FULLY FUNDED, or PART FUNDED.

Our full price list with full terms and conditions that apply are available upon request for potential parents, but as an introduction and to outline any additional costs that may be applicable dependent on your chosen method we have published the main details below.

The following applies to 'Stretched Funding' whereby we offer funding over 51 weeks of the year. We do have limited Term-Time only places also available and prices are available upon request.

Page 3 **Option A:** Partly Funded Spaces

These include additional top-up hours to fit into standard Ivy Mill session times and are available to all parents, subject to availability and to being eligible for Free Entitlement as per government criteria.

These are based on set times and dates, and as a nursery we offer a limited amount of spaces only on this basis. These spaces are subject to availability, and government eligibility criteria.

This option includes additional hours which are charged at the standard, relevant pro-rata rate to fit into standard Ivy Mill session times.

This option is available to *all* parents, subject to availability and to being eligible for Free Entitlement as per government criteria.

*For 2, 3 & 4 year old funding, meals are not included and are charged as an extra.

This extra is optional, and if not required then parents can supply a packed lunch – see conditions later in policy for further details.

Option A: Summary

These sessions are designed to ensure that all parents can benefit from full standard Ivy Mill sessions, and are also able to receive the financial benefit of having Free Entitlement funding applied.

*There is a meal time at approximately 11:50 and 16:00 each day. These meals are not included as part of the session cost for 2, 3 and 4 year olds only, and are chargeable as an extra cost at the amount shown. This is not a compulsory option, and parents are free to provide their child with a packed lunch if they wish which will incur no additional cost. If you do not wish to receive nursery lunches then we will need to be notified that this is not required with a *minimum of 4 weeks notice*. We are a **Nut-Free nursery**, and all food provided must consider our nursery food and healthy eating policies which are available on request.

These sessions all include additional hours as shown on the previous page to fit in with standard nursery session times. If you do not want to pay for additional hours and wish only to claim for Free Entitlement hours, then please refer to Option B for the regulations regarding that.

All sessions are subject to availability, and to parents being eligible as per the government criteria. See the Terms and Conditions for further information on this.

Option B: Fully Funded Spaces

- These can be claimed between **13:00 and 17:24 Monday to Friday** (each session is 4 hours, 24 minutes)
- There is a meal time at approximately 16:00 each day. This meal is not included as part of the session cost, and parents are to provide their child with a packed lunch. We are a Nut-Free nursery, and all food provided must consider our nursery food and healthy eating policy which are available on request. There is an option to pay an additional cost for Ivy Mill to provide the meal.
- These sessions cannot be used in conjunction with any funded morning sessions, and there are no options to have additional hours. Should any additional sessions be required and funding is still required, please see Option A for partly funded session conditions.
- As a nursery, these spaces are capped and are offered on a first come first served basis subject to our admissions policy.
- Late collection fees will be charged at the current rate as detailed in standard price list and applicable fees.
- All sessions are subject to availability.
- All sessions are subject to parents being eligible as per the government criteria. See the Terms and Conditions and Frequently Asked Questions Sections of this document for further information on this.
