connected disabled professionals with work-based learning opportunities and career
development support while providing employers with training and resources to support
disability inclusion. Apprentices gained practical skills and employment experience
while participating organizations strengthened inclusive hiring practices.

Entrepreneur Training & Ecosystem Programs: 2Gether-International delivered
entrepreneurship training and ecosystem-building initiatives through partnerships
including Truist and Making Space. These programs focused on strengthening inclusive
entrepreneurship ecosystems by training professionals, mentors, and service providers
to better support disabled entrepreneurs and improve access to business resources and
networks.

Accelerator Programs: 2Gether-International delivered multiple accelerator cohorts in
the United States, Latin America and the Caribbean supporting early-stage disabled
founders building high-growth ventures. U.S. cohorts included Health Innovation, AI,
and MVP-focused accelerators designed to strengthen business models, customer
validation, and investment readiness. In Latin America and the Caribbean, two
accelerator cohorts were delivered in partnership with IDB Lab. Across programs,
founders received intensive mentorship, workshops, and pitch development support to
advance venture growth and improve access to capital and customers.
