Cohorts for Founders with Disabilities: Selected participants, all of whom are Disabled Founders of early-stage, high-growth, tech startups, are immersed in 2GI's accelerator program (typically 10 weeks) designed to improve their pitch and business model, and to instill the mindset that disabilities can be a competitive business advantage. The accelerator program culminates in a pitch competition, providing the entrepreneurs with an opportunity to be awarded seed funding. 2GI's Cohorts are supported by corporate partners and sponsors, which have included Comcast NBCUniversal and Google, as well as the Small Business Administration. Venture Labs: 2GI has introduced Venture Labs, an online accelerator program for idea-stage Entrepreneurs with Disabilities, designed to take participants from having a great idea to having their first customer in only eight weeks. Founders will 'think' and develop their respective ideas, 'talk' to potential customers about the idea.
