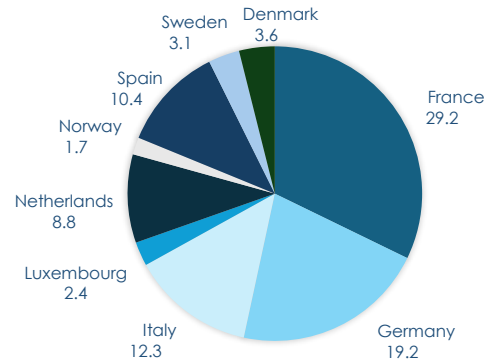

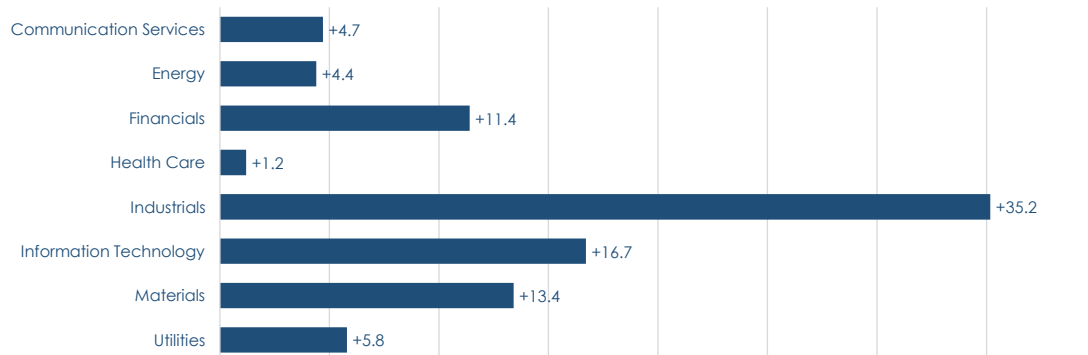
### CURRENCY EXPOSURE
