

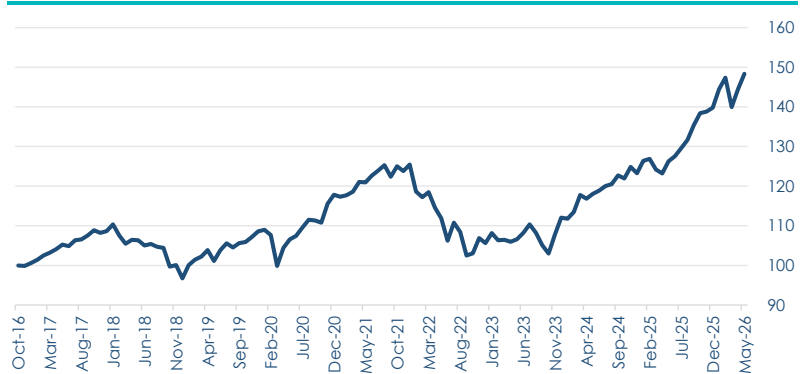

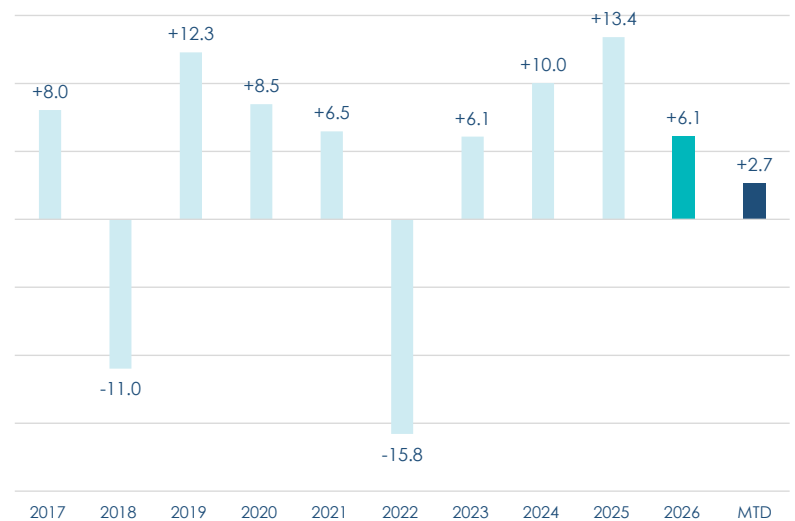
## INVESTMENT OBJECTIVE

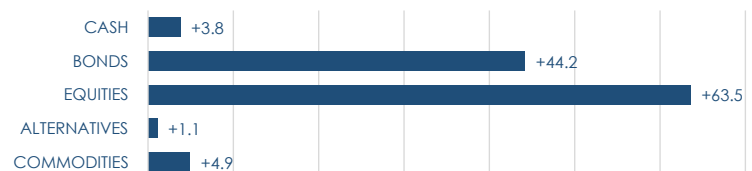
## PERFORMANCE (Institutional Expert Class EUR)
