

A1 Pet Motel Pet Boarding Agreement

Terms

THE PROPRIETOR AGREES TO ACCEPT THE ABOVE PET FROM THE OWNER/S AND TO PROVIDE THE SAID PET WITH QUALITY FOOD, SHELTER AND ATTENTION SUBJECT TO THE FOLLOWING CONDITIONS:

A. FEES:

The owner/s agree to pay the full amount of Boarding Fees at the daily rate entered into this agreement for each calendar day and agrees further to pay such Boarding Fees as may accrue after the expected collection date. Check out must occur before 9:30am otherwise an additional day of accommodation is charged at the daily rate. Party rates do not apply.

B. RELEASE & INDEMNITY:

The Owner/s agree expressly that the pet shall be and remain at the complete risk of the Owner/s as to accident, illness or misadventure of any description whilst the pet remains on the Proprietor's premises, or in any way under the control of A1 Pet Motel Tamworth, including during transportation of the pet or from the A1 Pet Motel. The Proprietor will take all reasonable care and precautions for the care and safety of the pet.

The Owner/s hereby release and indemnifies the Proprietor from all proceedings, actions, claims, suits and demands in relation to health, condition, management or loss by whatever cause of the Pet throughout Boarding period. Without limiting these indemnities, it is expressly agreed that the Proprietor shall not be responsible for any injury or illness to, or theft or death of Pet occurring during Boarding period.

C. VETERINARY COSTS:

The Owner/s hereby authorise and requests the Proprietor to call in a Veterinary Surgeon to attend the Pet for any reason and at the sole and absolute discretion of the Proprietor and the Owner/s hereby agree to be responsible for all costs of all professional charges and treatments rendered in such Veterinary care to Pet. Further, Owner/s hereby expressly authorise the Proprietor to incur such costs and charges in the name of the Owner/s personally, and indemnifies the Proprietor accordingly.

D. COLLECTION:

The Owner/s agree to drop off and collect their pet within the set business hours of A1 Pet Motel and to give the Proprietor as much advance notice as possible of the intended time and date for collection of the Pet within the set business hours of A1 Pet Motel.

E. ABANDONED PETS:

If the Pet is not collected by the Owner/s (or Agent authorised in writing) within one (1) week of expected collection date shown the Proprietor shall be entitled, and Owner/s

hereby consents that the Proprietor:

- (i) Sell or otherwise remove the Pet from the premises as the Proprietor shall think fit in their absolute discretion; and
- (ii) Apply the proceeds of any such disposal against outstanding Boarding Fees and any Veterinary costs and charges outstanding; and
- (iii) Recover from the Owner/s any moneys then still remaining due and payable.

F. HEALTH WARRANTY:

The Owner/s hereby warrants and covenants with the Proprietor that the Pet is free from ill-health or contagious disease and is free of any dangerous or vicious condition or temperament (other than noted above).

G.

The Owner acknowledges that the signing of this Contract shall create a lien over the animal in favour of A1 Pet Motel Tamworth, which lien shall continue to exist whilst any moneys are owing pursuant to the contract.

Payment Method:

The Owner/s shall agree to pay via the accepted methods of payment only, those methods being cash or Australian currency, master card, visa card or money order. Cheques are not accepted.
