### HOW TO APPLY FOR A NEW CONTRACT TIME OR RENEW YOUR PRESENT CONTRACT TIME FOR THE 2026-2027 SEASON:

1. Select a group representative to fill out the application on the next page.
2. Return the application with a non-refundable deposit of \$100 per contract court by July 15<sup>th</sup>. All names listed must join the Bass River Tennis Club to participate in a contract time.
3. New contract times will be granted if space is available. Contract renewals have priority.
4. Once the contract season begins, the group representative must notify the club if there are any changes among players in their group. Contract billing should be finalized by September 30<sup>th</sup>. After that date, we ask contract players to settle any billing issues amongst themselves.

- Monday Contracts: Meets for 35 weeks. Closed Labor Day
