IF YOU WANT TO REQUEST A 2026 VEHICLE IDENTIFICATION PERMIT, COMPLETE ALL THE INFORMATION ON THE APPLICATION AND SUBMIT COMPLETED APPLICATION TO YOUR UNION DELEGATE OR EMAIL TO [PLACARDFORM@NYSCOA.ORG](mailto:PLACARDFORM@NYSCOA.ORG) BY APRIL 03, 2026.

VEHICLE IDENTIFICATION PERMITS ARE TO BE USED WHEN ON OFFICIAL COURT BUSINESS AND MAY BE USED ONLY IN APPROVED AREAS.

THE VEHICLE MUST BE REGISTERED IN THE MEMBERS NAME OR A FAMILY MEMBERS NAME.

NO MEMBER MAY LOAN HIS OR HER PERMIT TO A FAMILY MEMBER AND/OR FRIEND.

ALSO, NO MEMBER IS TO COPY HIS OR HER PERMIT OR GIVE PERMISSION FOR ANYONE ELSE TO COPY THE PERMIT.

IF THE PERMIT IS LOST OR STOLEN, REPORT SUCH LOSS OR THEFT TO THE UNION OFFICE IMMEDIATELY. **DO NOT FILE AN O.C.A. INCIDENT REPORT.**

WHEN YOU RECEIVE THE 2026 VEHICLE IDENTIFICATION PERMIT, YOU MUST IMMEDIATELY RETURN YOUR 2025 VEHICLE IDENTIFICATION PERMIT TO YOUR UNION DELEGATE AND/OR THE UNION OFFICE.

ANY MISUSE OF THE VEHICLE IDENTIFICATION PERMIT WILL RESULT IN THE SUSPENSION OF ALL PARKING PRIVILEGES AND REVOCATION OF THE PERMIT.
