ABOUT AVENUES FOR JUSTICE

Avenues for Justice (AFJ) is a NYC non-profit organization that has continued to provide free-post arrest support to at-risk young people for over 45 years.

As one of the first Alternative-to-Incarceration (ATI) programs for young people and young adults in the country, AFJ has protected NYC's court-involved and at-risk youth from incarceration, replacing cells with services.

AFJ provides free on-going court advocacy along with their HIRE UP online and onsite enrichment programs for workforce training, education, mental health and mentoring to over 600 young people, ages 13-24, each year.

On average, 92% of AFJ's court-involved Participants avoid reconviction within three years of enrollment into the program, making our ATI program one of the most successful, cost-effective models in the US.

Services for program Participants are provided online and onsite at AFJ's two community centers in Harlem and the Lower East Side, and at AFJ's headquarters inside the Manhattan Criminal Courthouse.

Court-Involved Participants receive court advocacy services with intensive case management while all Participants receive HIRE UP services for job readiness and certification, youth empowerment and legal rights, life skills, mental and physical health wellness, academic support, tutoring, and more.

AFJ also provides referrals to third party specialists for all Participants when needed.

AFJ operates programs for two main groups of Participants:

- 1) "Court-Involved" Participants who are in the criminal justice system; and
- 2) "At-Risk" Participants who are at-risk of involvement with the criminal justice system, often referred to by school, family, community members, or other court-involved youth.

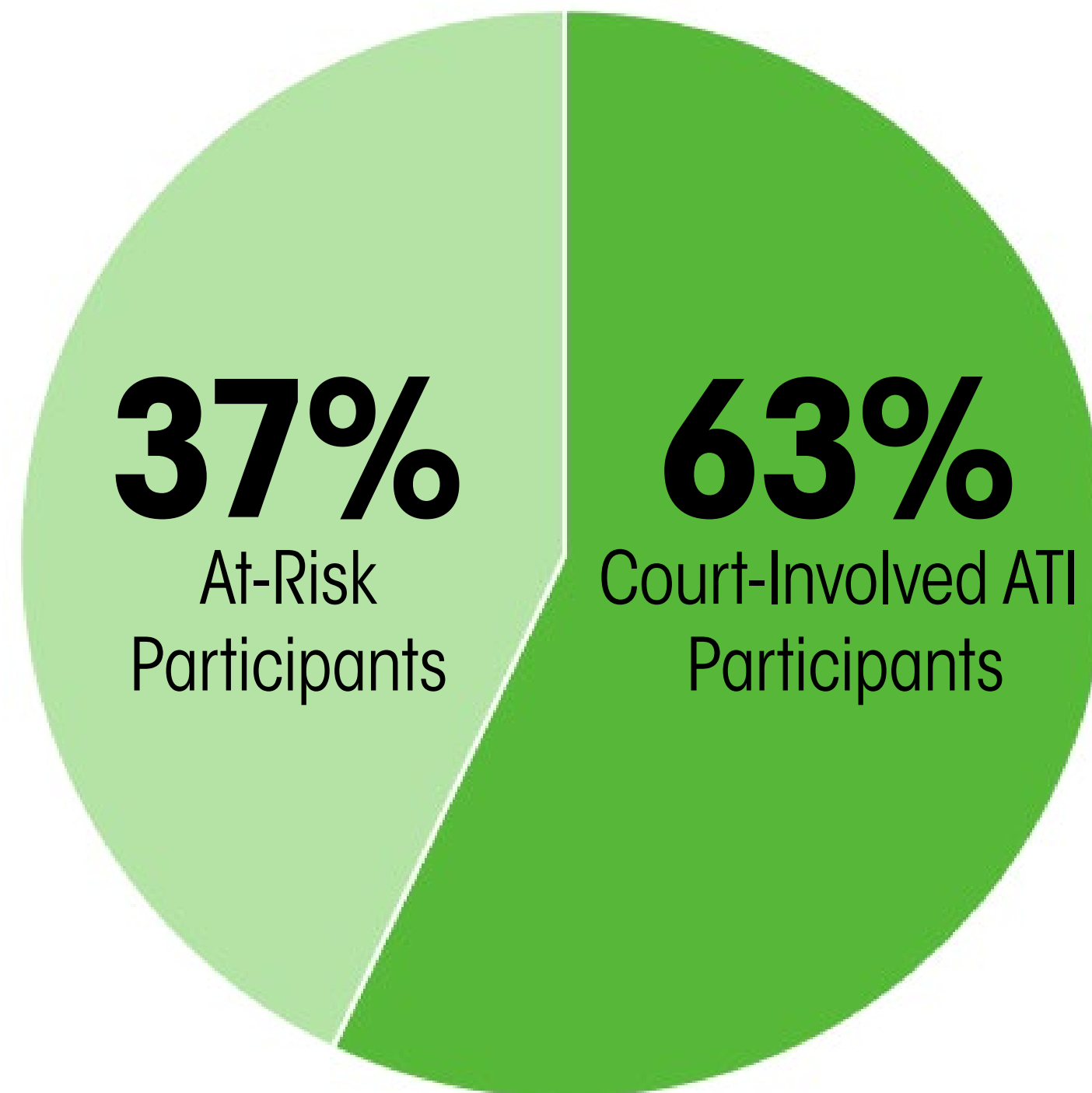


OUR PARTICIPANTS

In 2025, AFJ served 692 ATI court-involved and at-risk Participants, ages 13 - 24, from across the city. These 692 young people participated in one of AFJ's two program areas:

433 (63%) were court-involved Participants enrolled in AFJ's intensive ATI program;

259 (37%) were at-risk Participants who participated in AFJ's crime prevention programs at our community centers;

OUR PARTICIPANTS

ATI PARTICIPANTS: AFJ's signature long-term ATI Participants who are court-involved and typically between the ages 18-24. Services include court appearances, school visits, regular counseling, curfews, mandatory check-in at centers, and monitoring of individualized services.

DIVERSION PROGRAM: Young people assigned to the Family Court Diversion program are mandated to community-based Alternative to Incarceration (ATI) organizations, such as AFJ, for a specific number of sessions or workshops-- typically 4 to 16. The program targets youth up to the age of 18. Diversion Participants receive the same services as other AFJ Participants but generally have a shorter stay.

RE-ENTRY PARTICIPANTS: Starting in 2020, AFJ began to track court-involved young people who spend time in jails and prisons. These participants have all spent at least one night in jail.

In 2025, AFJ served 371 ATI court-involved youth, ages 13 - 24 from across the city. These 371 Participants can be broken down into three categories:

142 (33%) were ATI court-involved Participants who did not spend time incarcerated or in the short-term diversion program;

247 (57%) were youth in Diversion Family Court who are offered the opportunity to have their case dismissed by the court if they comply with a short AFJ mandate;

44 (10%) were re-entry Participants who were referred to AFJ after spending a period of time incarcerated.



EVIDENCE-BASED APPROACH

EFFECTIVE ATI: Needed now more than ever.

Avenues for Justice's long history of success proves that providing support, skills and stability is far more effective at turning lives around than incarceration. Our organizational strength derives from seeing young people not as data points, but as people with real stories to tell about the importance of second chances—especially when empowered with the right services:

INSTITUTIONAL TRUST: With headquarters inside the Manhattan Criminal Courthouse. Judges, prosecutors, defense attorneys, probation officers, and court resource coordinators view AFJ as a reliable and effective referral source.

INDIVIDUAL ACTION PLANS: Our Court Advocates create Individual Action Plans designed to address immediate and long-term needs and help Participants strive for personal and professional success.

GUIDING FAMILIES: AFJ addresses the needs of our Participants' families and supports them through emergencies which can place them in a crisis and derail the Participant's progress.

COMPLETING COURT REQUIREMENTS: AFJ provides free court advocacy until a Participant satisfies the court's requirements and receives a favorable disposition of their case. This could be a dismissal, probation and/or a plea to a reduced charge or reduced sentencing without incarceration.

LOW RECIDIVISM: We track Participant recidivism rates for three-years and six-years from program enrollment. In 2021, AFJ initiated Participant and Alumni feedback surveys to document long term outcomes measured by non-criminal history and quality of life metrics supplemented by personal accounts.



2025 FINANCIAL HIGHLIGHTS

AFJ maintains an annual budget just below \$3.5 million. We keep our overhead low: **81% of the AFJ budget goes directly to support program.**

EDUCATION

RECONNECTING WITH SCHOOL: Court advocates help Participants re-enroll in school, and meet frequently with school administrators and teachers to ensure that Participants are succeeding at their studies and are on track to graduate.

TUTORING: Currently, Avenues for Justice maintains a bank of 60 volunteers, including academic tutors and an ESL Instructor, who help AFJ Participants with schoolwork, exams, and admissions forms to complete high school and advance to college.

CORPORATE-LED WORKSHOPS: Launched in September 2020, corporate partners facilitate job readiness and financial literacy training with mock interviews; resume writing; basics of budgeting, bank and credit accounts; dress for success; and mentoring. The program includes guest speakers who are successful in unconventional careers and job structures (work for hire, freelance, project based work) to expand the idea of a career. Partners since the launch include JPMorgan Chase, City National Bank, Goldman Sachs, New York Junior League, Rothschild & Co, UBER Technologies and BlackRock.

ADVANCING TO COLLEGE: When Participants successfully obtain a diploma, Avenues for Justice works with them to enter college and/or a trade school. Assistance includes college visits, SAT-prep and assistance with applications and financial aid.





HIRE UP: EMPLOYMENT TRAINING

In 2025, AFJ's HIRE UP program included a wide roster of job training and certification, educational support, teen empowerment and legal rights workshops, life skills and civics training, and mental and physical health wellness programs, both online and onsite at the Harlem and Lower East Side community centers.

Our research shows that our Participants need assistance to obtain long term employment--particularly in industries outside of retail and hospitality, which tend to have higher turnover rates and lack stability. It is for this very reason that AFJ tailored a unique approach to job readiness beyond the traditional resume and cover letter workshops. The goal of our HIRE Up program is to make Participants more marketable and to successfully complete the program with professional hard and soft skills.

HIRE UP: EMPLOYMENT TRAINING (CONT.)

CERTIFICATIONS: With the success of our certification programming in 2025, AFJ continues to offer OSHA Safety Education and Training program, along with the Flagger and Scaffold User Training, and Security Training quarterly; alternating between centers.

Our CPR certifications will also be offered twice per year through our partnership with the New York Junior League (NYJL). Along with our certifications, AFJ continues to champion continued education through our mandatory Digital Literacy requirement for all our Participants. In an increasingly digital world, AFJ is determined to provide our Participants with the skills and tools needed to navigate technology for professional advancement.

PAID INTERNSHIPS

In addition to expanding our HIRE Up workforce readiness trainings, Avenues for Justice piloted a paid internship program, funded by AFJ, that paired Participants who passed the interview process with a local business that fit their personality and career goals. Each internship lasted for 8 weeks and a total of 125 hours paid at \$17 an hour.

Between our spring and fall cohorts, we had 31 interns complete their internship at over 20 different local businesses, majority BIPOC-owned, in industries such as event production, hospitality, food and beverage, security, technology, and fitness.

Since program launch in 2023, 90 different Participants have completed 120 total internships.

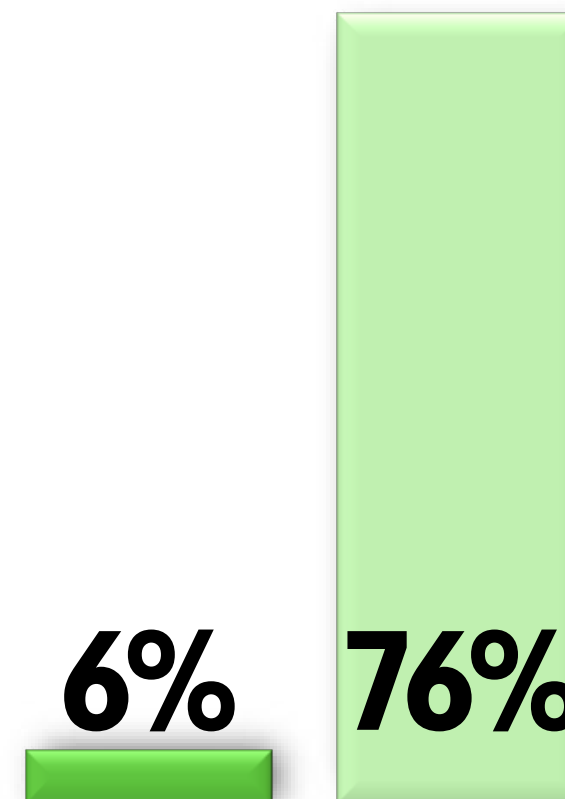

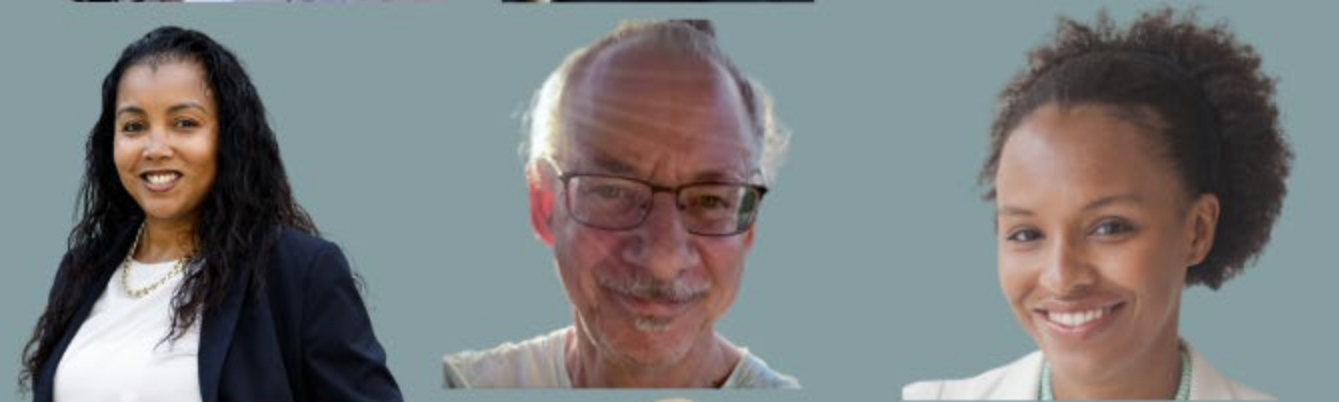
