AFJ SERVES 650+ JUSTICE-INVOLVED AND AT-RISK YOUNG PEOPLE ANNUALLY FROM 48 NYC COUNCIL DISTRICTS. COURT ADVOCATES DEVELOP INDIVIDUAL ACTION PLANS (IAPS) WITH EVERY PARTICIPANT, INTEGRATING WORKFORCE DEVELOPMENT, EDUCATION SUPPORT, MENTAL-HEALTH WELLNESS, TEEN EMPOWERMENT SESSIONS, AND VIOLENCE-PREVENTION PROGRAMMING. ON AVERAGE, 94% OF COURT-INVOLVED PARTICIPANTS ARE NOT RECONVICTED WITHIN THREE YEARS OF ENROLLMENT. AFJ OPERATES FROM COMMUNITY CENTERS IN THE LOWER EAST SIDE AND HARLEM AND OUR HEADQUARTERS IN THE MANHATTAN CRIMINAL COURT. BEING ROOTED IN THESE NEIGHBORHOODS ENSURES DEEP TRUST AND ACCESSIBILITY FOR YOUNG PEOPLE DISPROPORTIONATELY AFFECTED BY VIOLENCE AND OVER-POLICING.

IN 2025, AFJ SAW STRONG OUTCOMES: OF THE CASES THAT HAD COURT OUTCOMES DURING 2025, 54% WERE ADJOURNED1 AND 28% WERE DISMISSED. LESS THAN 3% OF SUCH OUTCOMES RESULTED IN INCARCERATING A PARTICIPANT. IN 2025, 257 COURT-INVOLVED PARTICIPANTS EXITED THE PROGRAM; 251 COMPLETED THE PROGRAM, WITH 206 ACHIEVING BOTH COURT-MANDATED AND AFJ-ESTABLISHED GOALS

OUR PROGRAM IS EFFECTIVE AND EFFICIENT. AFJ'S LONG-TERM RECIDIVISM DATA SHOWS THAT ONLY 6% OF PARTICIPANTS ARE RECONVICTED WITHIN THREE YEARS OF ENROLLING, COMPARED TO 42% OF NYC PAROLEES IN A COMPARABLE STUDY. AMONG SUCCESSFUL GRADUATES, OVER SIX YEARS, ONLY 14% OF PARTICIPANTS WERE RECONVICTED, WITH MOST OF THESE CONVICTIONS BEING FOR
