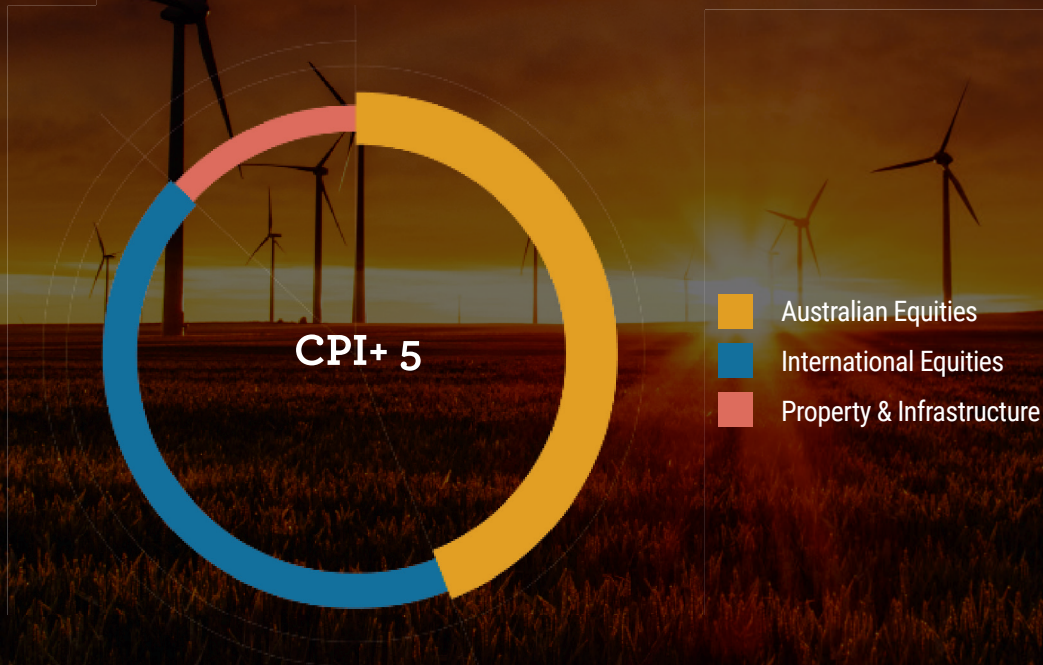


Better World Portfolio 5:



Overview

Investment Objective

The investment objective is to achieve a return of CPI + 5% per annum over the long-term by investing in a diverse mix of asset classes including Australian equities, international equities, property, infrastructure, alternatives, fixed interest and cash.

Responsible Investing

InvestSense aims to identify underlying investment strategies/managers that invest in an ethical or socially responsible manner or invest in companies that are positively contributing to a sustainable future or positive social outcomes.

Generally, these investment strategies will aim to avoid, or be biased away, from investments that are inconsistent with responsible investment considerations. These include sectors such as fossil fuels, gaming, alcohol, tobacco or defence. These managers may also demonstrate a clear commitment to investing in stocks that provide a positive contribution to society or the environment or are targeting investments that relate to the UN Sustainable Development Goals.

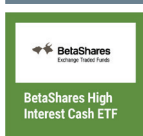
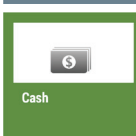
