SUBJECT: A Resolution to Appropriate Funding for the Rt. 66 Cheyenne and Arapaho Tribes Mural Project.

WHEREAS: The Cheyenne and Arapaho Tribes are duly recognized by the United States Secretary of the Interior as a self-governing, Sovereign Nation, that is a federally recognized Indian Tribe with all rights, privileges, and powers attended thereto as a sovereign government under a constitution approved by the Secretary of Interior; and

WHEREAS: Article VI, Section 5(a) of the Constitution provides that the Legislative power shall be vested in the Legislature, which includes the powers to make laws and resolutions in accordance with the Constitution which are necessary and proper for the good of the Tribes; and

WHEREAS: Article VI, Section 5(d) of the Constitution authorizes the Legislature shall have the power to raise revenue and appropriate funds for expenditures; and

WHEREAS: The Cheyenne and Arapaho Tribes Route 66 Roundtable Group have approved a Mural Project to be placed along the iconic Route 66 corridor as part of the Route 66 100 year Centennial to be celebrated in 2026; and

WHEREAS: As a result of collaboration efforts, the City of El Reno has offered support for mural space at the Mobility Hub in the downtown area aimed at celebrating cultural identity and enhancing tribal presence along the Mother Road; and

WHEREAS: The Mural Project marks a key step in creating a shared vision for Route 66 projects that honor Cheyenne and Arapaho heritage while contributing to the vitality of communities across Western Oklahoma. This project will serve as a cultural landmark and major tourist attraction drawing visitors from across the country; and

- **WHEREAS:** The awarded Artist(s) will be of Cheyenne and Arapaho descent who can envision and convey the historical history and presence of our Cheyenne and Arapaho people; and
- **WHEREAS:** The Cheyenne and Arapaho Tribes support the promotion of cultural representation and historical significance through public art, and this Mural will provide a lasting symbol of the Tribe's history, strength, and presence; and,

NOW BE IT FURTHER RESOLVED The Tenth Legislature of the Cheyenne and Arapaho Tribes, pursuant to its Constitutional authority, hereby appropriates \$30,000 from the Tax Commission Funds for the Route 66 Mural Project under the direction of the Planning & Development Program.

Pursuant to Article VI, Section 7, subsection (a)(iv) of the Tribes Constitution reads in part: "All Bills passed by the Legislature shall be presented to the Governor for signature or veto. All laws shall take effect thirty days after signature by the Governor or veto override by the Legislature unless any Member of the Tribes submits to the Coordinator of the Office of Tribal Council a petition signed by at least one hundred fifty Members of the Tribal Council seeking to repeal the law or resolution at the next Tribal Council meeting. If the Tribal Council fails to repeal such law or resolution at the next Tribal Council where the matter has been properly placed on the agenda for the Tribal Council meeting, such law or resolution shall become effective immediately."

Pursuant to Article VII, Section 4, subsection (g) of the Tribes Constitution reads: "The Governor shall have the power to sign any enactment passed by the Legislature into law or to veto any enactment passed by the Legislature within ten days of passage with a written explanation of any objections; and if the Governor takes no action within ten days, then the enactment shall become law in accordance with this Constitution."

Date of action:						

Route 66 Round Table:

The Rt. 66 Round Table discussion group began meeting in March 2024 for the sole purpose of planning some type of tourism event to celebrate the 100 year Rt. 66 Centennial to take place in 2026. We've had several idea's however, to-date, no funding has been obtained and no definitive plan was made. Past project idea's included the following:

- Great Plains Bison Adventure/Concho (Bison Tour and Living Village): A prior grant submission was not favorable as no definitive plans could be made such as how to setup the business side, who would be responsible for it, etc.
- Trading Post and Event Center/Clinton: Tribal Leadership was not supportive of this endeavor; they didn't want to allocate funding to renovate the building.
- Bison/Native Statuette: Initially this was an idea for the Mobility Hub. Subsequently Nathan Pratt
 obtained approval for a 39 ft. Bison Sculpture to be installed at the Adams Park Project. No further
 discussion.
- Cheyenne and Arapaho Trade Pavilion/El Reno: A day-to-night public space designed to support vendors, artists and educators through flexible infrastructure a shaded, open-air space that can be used for markets performances, storytelling, craft workshops and cultural exchange during the day; by night, the structure transforms into a glowing sculptural installation using programmable lighting and interpretive elements to share Cheyenne and Arapaho heritage, enhance pedestrian safety and extend civic life after 5 pm.
- Petree Plaza Event Canopy/Buffalo Wallow/El Reno: offers shade, comfort, and identity for community events, markets, performances, and ceremonies transforming an everyday plaza into a place of gathering, storytelling and renewal. Initially this project was for the downtown Petree Plaza area, however, when presented to the El Reno Rt. 66 Group, they want it to be included in the Adams Park Master Plan, in the same vicinity as the 39 ft. Bison Sculpture by Mr. Pratt. We will apply for this project thru the Rt. 66 Grant, due Sept. 30th
- Mural Project: The City of El Reno is open to providing building space for a Mural. We toured several
 locations in the downtown area with Matt Sandidge, City Planner in early August; we are reviewing site
 locations at this time. We are preparing a Resolution asking the Legislature to appropriate \$30,000 for
 the Mural Project from Tax Commission Funds. A Rt. 66 Keep American Beautiful Micro-grant was
 applied for in August 2025 for \$5,000 to supplement this project.







Painted 1980 by Charlie Beecham







This is the El Reno Heritage Mural at the corner of Bickford and Woodson, next to the Heroes Plaza. Each of the nine panel illustrates a point in the history of El Reno's, Canadian County and western Oklahoma in general. From left to right the panels depict the Cheyenne-Arapaho Reservation, the Darlington Indian Agency, Ft Reno, the Rock Island Railroad, El Reno, the Original Oklahoma Land Rush, the Caddo Springs Station, Jesse Chisholm Trail, and Francisco Coronado.

The mural was commissioned in April of 1980 by Oklahoma Federal Savings and Loan Association which was painted by Charles Beecham and completed in 1980
