Article VI, Section 6, subsection (a) reads in part: "The Legislature shall convene in Concho for twelve Regular Sessions of up to two consecutive days beginning on the second Saturday of each month beginning at 9:00 am."

Article VI, Section 7, subsection (a) (ii) reads in part: "All Bills shall be published in a legislative calendar for at least thirty days prior to action on the Bill. All Bills shall be made the subject of a public legislative hearing prior to action on the Bill."
