Evenlode Catchment Partnership Project Officer Job Description & Person Specification

Office Base: Manor House, Little Wittenham, Abingdon, Oxfordshire, OX14 4RA

Work location: Evenlode Catchment, West Oxfordshire.

The post allows for some flexibility in home working but a minimum of four days office based work or site based work is expected.

Work hours: 35 hours

Duration: 2 years in the first instance, with a plan to extend it for a longer period subject to funding, 6 months probation.

Salary: £37,006 FTE

Benefits: Pension with 9% Employer's Contribution. 20 days leave plus the usual public holidays in England and Wales, as well as an additional three days between Christmas and New Year when the office is closed.

Salaries may be subject to an inflationary increase each year, subject to Wild Oxfordshire Trustee's approval.

Evenlode Catchment Partnership

Catchment partnerships were set up by the Environment Agency in 2014 to involve communities in trying to improve the health of our rivers. The country has been divided up into catchment and sub-catchment areas. The Evenlode Catchment Partnership (ECP) is a sub-catchment, mainly within West Oxfordshire District Council. It is made up of about 20 partner organisations from which a Steering Group is formed to discuss and plan projects. Water Restoration Fund Programme

The Evenlode Catchment Partnership has been fortunate in being awarded a substantial grant from the Water Restoration Fund to continue its programme over the next 2 years. This funding supports the delivery of the catchment plan using a holistic approach to improve the environment. The plan covers four main themes: Water Quality and Advocacy; Biodiversity, Habitat and Landscape; Natural Flood Management; Education, Community, Access and Recreation. Project and planning meetings for the Steering Group are held roughly monthly with a small group of theme leads and representatives. Technical working groups plan the project work and direction with sign off from the SG for budget control.

Overall purpose of the job

Work with our ECP Project Manager, Administration Officer and delivery partners to inspire and empower partners, individuals, communities and organisations to enhance their environment by providing practical advice and extending the reach of our engagement and to help to deliver the catchment plan.

Main responsibilities

- Support the Project Manager in consolidating, co-ordinating and supporting the work of partner organisations to deliver their projects and milestones and reporting within the Water Restoration Fund programme.
- Support the Project Manager in planning, delivering and co-ordinating projects and milestones within the plan and in the hosting role, including taking leadership of specific deliverables and feeding back information on progress to the wider partnership.
- Support the Project Manager in engaging with landowners and farmers to identify future opportunities for river restoration, natural flood management and wetland creation projects.
- Support the Project Manager in design, contract management of delivery projects and in making applications to secure future funding.
- Liaise with the Administration Officer to ensure effective and impactful communication and outreach, including through the use of the website and social media to share project stories, learnings, updates and events.
- In conjunction with our delivery partners, help foster links with parish and town councils and community groups as part of raising the ECP profile and develop an understanding of how the ECP can support and encourage them in socio-environmental development.

A separate Person Specification sets out the experience, skills, knowledge, qualifications and attributes which will be needed to carry out the job. We are looking for a Chartered Landscape Architect.

Ability to travel to the Evenlode Catchment in West Oxfordshire to visit groups and sites outside of public transport networks is required.

Flexibility is required to be able to work unpredictable hours, including working evenings and weekends.
