Also present: Douglas Beri Jr. – Executive Director, Tammie Robinson – Office Administrator, Tom Beresnyak, Hunter Overdorff, Alysha Trexler, and John Somonick-Associate Directors, Stephen Campbell – Penn State Extension, Ariel Coleman – USDA Natural Resources Conservation Service (NRCS), and Toby McIlwayne - District solicitor participating remotely.

#### **PUBLIC COMMENTS - none**

Peace moved to approve consent agenda items including accepting minutes of the previous meeting as presented, treasurer's report to be filed subject to audit, correspondence, DEP delegated programs reports and staff reports, second by Simpson, motion carried.

VanHorn moved to pay the bills as presented, second by Andrie, motion carried with Simpson abstaining.

<u>DEPARTMENT OF ENVIRONMENTAL PROTECTION DELEGATED PROGRAMS REPORT</u>
Eight erosion and sediment control plans were reviewed, and four Chapter 102 site inspections were conducted.

### ASSOCIATE DIRECTOR REPORTS

Overdorff reported local policy will be developed for the Indiana County Farm Bureau at their annual meeting/picnic being held at the Brush Valley Park on July 19.

Trexler reported Western PA Conservancy is working with the PA Game Commission to replace bridges in state game lands on Ferriers Run that will greatly enhance aquatic organism passage. Trexler commended District staff on their Growing Greener grant work and applications being developed.

Beresnyak reported on webinars being offered by Penn State Extension.

Campbell reported equipment demonstrations will be held at Rock Springs on July 8. The Indiana County Manure Management workshop will be held at the Dustin Heeter farm in Clarksburg on September 5. Research projects are being conducted, and Extension is seeking volunteers to allow western bean cutworm traps to be placed on their farm. Peace volunteered to participate. A no-till alliance meeting/field day is planned for July 22 in Butler. Ag. Progress Days is set for August 12-14. A Farming for Success workshop is planned in Landisville in August. Campbell is developing a drone cover cropping workshop to be held this fall in Butler.

Somonick reported that the Indiana County Office of Planning and Development is working on a Subdivision and Land Development Ordinance (SALDO) for solar installations. If the state of Pennsylvania develops a solar SALDO, it will likely supersede any locally developed SALDO.

#### FIELD REPRESENTATIVE'S REPORT

Taylor Null has resigned from the position which is now vacant.

# **COOPERATING AGENCY REPORTS**

Coleman reported NRCS has completed a heavy use area application, and they received one additional forestry application. The Conservation Reserve Program application period is still open until July 31.

Beri reported that the Friends of Indiana County Conservation District's small agriculture grant application period is open until the end of June. Two \$1500 grants are planned to be awarded.

Andrie moved to support Beri voting yes at the upcoming PA Association of Conservation Districts (PACD) annual conference for a three-year PACD dues increase for each county conservation district in the amount of \$300 the first year, and \$200 for each of the following two years, second by VanHorn, motion carried.

VanHorn moved to approve the personnel committee recommendation for employee annual raises as presented, effective for the pay date of July 4, 2025, second by Simpson, motion carried.

Peace moved to approve contracting Rural Support Partners for strategic planning and stakeholder engagement services not to exceed \$13,000, pending signing a contract for the PA Department of Agriculture Ag Innovation grant, second by Simpson, motion carried.
