We cultivate educational, economic, cultural, social, and physical and mental health resources in partnership with newcomers (refugees, immigrants, asylum-seekers, and others who are new to the United States) to empower them to achieve system change that supports their well-being and integration in their new communities. We do this by promoting mutual learning to help newcomers and others living in America understand each other and develop and support effective and just policies, collaborating with other organizations, government agencies, and individuals to achieve our vision, developing, implementing, adapting, evaluating, and disseminating programs that benefit newcomers, including the Refugee Well-being Project (an innovative model for connecting newcomers with people and resources in the United States to promote mutual learning and improve mental health), and building capacity and leadership skills of newcomers.

In 2024, volunteers assisted with UVNR programming, particularly supporting the Youth Empowerment Program, Tea Circle, and the Refugee and Immigrant Wellbeing Project. Volunteer tasks included program facilitation in areas of their expertise, childcare and transportation for program participants, and miscellaneous tasks as needed.

Form 990, Part III, Line 4a - First Accomplishment**Increasing Community Responsiveness to Newcomers/System Change:**

UVNR staff provided information/resources to 21 adult participants in Tea Circle monthly.

UVNR conducted 3 mental health training sessions with 87 community partners; 41 participants were direct mental health service providers. UVNR also conducted 3 community coalition meetings with over 14 different collaborating agencies/organization and provided 440 instances of mental health messaging through social media, tabling events, and case managers. Staff dedicated more than 430 hours to system change efforts and participated in over 1,300 meetings, events, and activities, advising on policy affecting newcomer education, healthcare access, mental health services, and detention practices.

Form 990, Part III, Line 4d - All Other Accomplishments

Youth Empowerment: 36 youth graduated from Cohort 1 of the Youth Empowerment Program, each receiving a \$500 stipend in May 2024 to go towards books, school clothes or other needs. 18 new youth were recruited for Cohort 2 that started August 2024.

Interpretation and Translation: Entered a formal contract to provide Santa Fe Public Schools with interpretation and translation services. Expanded our services with St. Joseph Home Visiting, and UVNR signed a contract with UNMH to be the first and only in-person interpretation service providers for newcomers seeking services in the state's largest public hospital and Level 1 trauma center.
