[PrisonPandemic](#) documents conditions of confinement inside California’s carceral facilities during COVID-19. The core PrisonPandemic team has worked with undergraduate and graduate students across campus to collect phone calls and letters from carceral facilities in California (including county jails, state and federal prisons, and immigration detention facilities). We have processed many of these stories and made them publicly available through an accessible, searchable digital interface. We are working with UCI Libraries’ Special Collections & Archives to permanently digitize and preserve these materials. PrisonPandemic provides one of the first discoverable and ethically collected sources of knowledge about how those incarcerated are experiencing the COVID-19 crisis. By collecting and sharing these first-hand accounts, PrisonPandemic increases public awareness, contributes to knowledge, and informs litigation about the conditions of confinement during the pandemic.
