## 3. Renew yearly contract with SPCA-Dog Control

Supervisor Howard stated he literally just got with the SPCA. They are aware of the difficulties that we've been having. They explained that with the onset of the summer vacation, they lose a lot of staff members. A number of people are going away, abandoning their dogs, so the calls go up, as a result of this and other concerns. The SPCA invoked their right, according to the contract to deny or decline to accept any more dogs. In a series of phone calls, we were assured that because of our municipal contract, municipal agencies are given preference to services over private individuals. Over the last 60 days, they have admitted that they took in a number of dogs from other municipalities, as well as from private citizens, but could not explain why they continued to refuse to accept a dog that we ended up keeping for 56 days. So it was a very irritating, not a pleasant call from our end, but very gracious responses from the SPCA that they would accept that dog effective today, but I should say that our town clerk made contact with Wyoming County Animal Control. They immediately sent someone out to look at the dog. They immediately, they did not take custody of the dog or control of the dog, but they set us up with a adoption agency actually referred a few people to see a dog, ultimately, an adoption agency that specialized in German shepherds, and good news is that effective Sunday, the dog was adopted with the help of Wyoming County. I suggested that we send a letter to Wyoming County Dog Control at least inquiring about using the kenneling services from Wyoming County. I learned that a onetime fee of \$50 whenever a dog was brought in and its 24/7 service does not require the town to kennel the dog at all. So, I would say back to the SPCA contract we could sign the contract. But also, Send a letter of interest to Wyoming County too.

#### 4. Solar project

Robert Klavoon said so we just had the public hearing and heard the comments from the public. The coordinated review process from Erie County Department of Planning NYS and NYS State DEC, the applicant has responded back to those sets of comments. Corinne and I still need to review those comments. At the next meeting I suggest the board would either declare a negative or positive declaration. Wendell will come with a recommendation to the board for the next meeting. But I guess my question to the board is, is there any other questions or additional information that the town board would like to see from the applicant prior to the next meeting. In addition to the SEQRA decision, we also have the special use permit piece as well, that would be the secondary approval for the project too. Corinne said at the next meeting, we'll go over the Part Two procedure form the applicant has already filled out the part one. It's essentially just a checklist where we will go through every potential impact, small or large, check things off, very conservatively, so things might be checked off large impact. It's not saying that there will be a large impact. We're just reviewing as if it's a checklist. And then after that, we will go through part three of the secret form, which will go through all of those impacts which we may have checked off and any sort of mitigation that the applicant has provided to us to make sure that we can make a decision on the record for the SEQRA.

We need to go through the comments in particular from Erie County Planning, again, referred to the new solar code, which was proposed, which I didn't think was appropriate, because we're still working under the old grandfather code with that. So you know, we'll work to make sure that that gets clarified with Erie County Department of Planning on that. But as of right now, Wendell also needs to be our site plan review for the specific site plan comments. There's also the pilot post community agreement and any special conditions on the SUP.

#### 5. Updates on code revisions

Supervisor Howard said before we start with the code revisions. it's my understand our building inspector has received several residents attempting to finalize a solar project. These are tier one or tier two projects. The project would need to be completed before the end of the year, to be eligible for the tax credits.

Robert Klalvoon said the board took action at the last meeting to extend the moratorium on the current solar code that is on the books. I do not know how you undo a portion of that moratorium for the residential solar part of that because the local law included that. Councilman Newman we can amend the current law and present at the Oct  $28^{th}$  Special Board Meeting and then call for a public hearing on November 12th, 202515. Robert Klavoon said item 3# new business we can prepare or basically write that document up right changing local law 2-2025 to allow for residential solar. Robert Klavoon said back to the code revisions, we have prepared six resolutions for the board. Three code - chapter 200 zoning, short term rental and the solar law as code revisions for the board to consider, that will prepare us to move forward with the public hearings at the next board meeting in November, any comments that you would have, we could certainly address those as we go. But I think we're at the point in the process where we call for public hearings.

# 3. Intro Local Law 3-2025 6-Month Moratorium on Battery Energy Storage Facilities

We can reintroduce with the wording changed, this would interfere with the tax credits which also include battery storage systems, So, it would be better if we modify that so this for the residents looking for tax credits.

MOTION#\_by Councilman Butcher and second by Councilwoman O'Connor, to table till the language is changed, we can reintroduce this law again, with wording corrected. Carried 5 ayes 0 noes

## 4. Temporary sign permit

The applicant requested permission to place a larger temporary "For Sale" sign exceeding the allowable 12 square feet under current code. The board acknowledged the property's tax delinquency approximately \$60,000 owed and noted that selling the property would benefit the municipality by restoring tax revenue. A compromise was discussed to allow the larger sign until the property is under contract, then replace it with a standard small sign if needed. The duration limit was 90 days from the date of listing or until the property is sold, whichever comes first. The sign must be temporary, not installed more than 24 hours before the active listing date. The board agreed that the sign requires a building permit and a \$25 fee. The members acknowledged the need for future code revisions to clarify sign procedures and authority across zoning districts.
