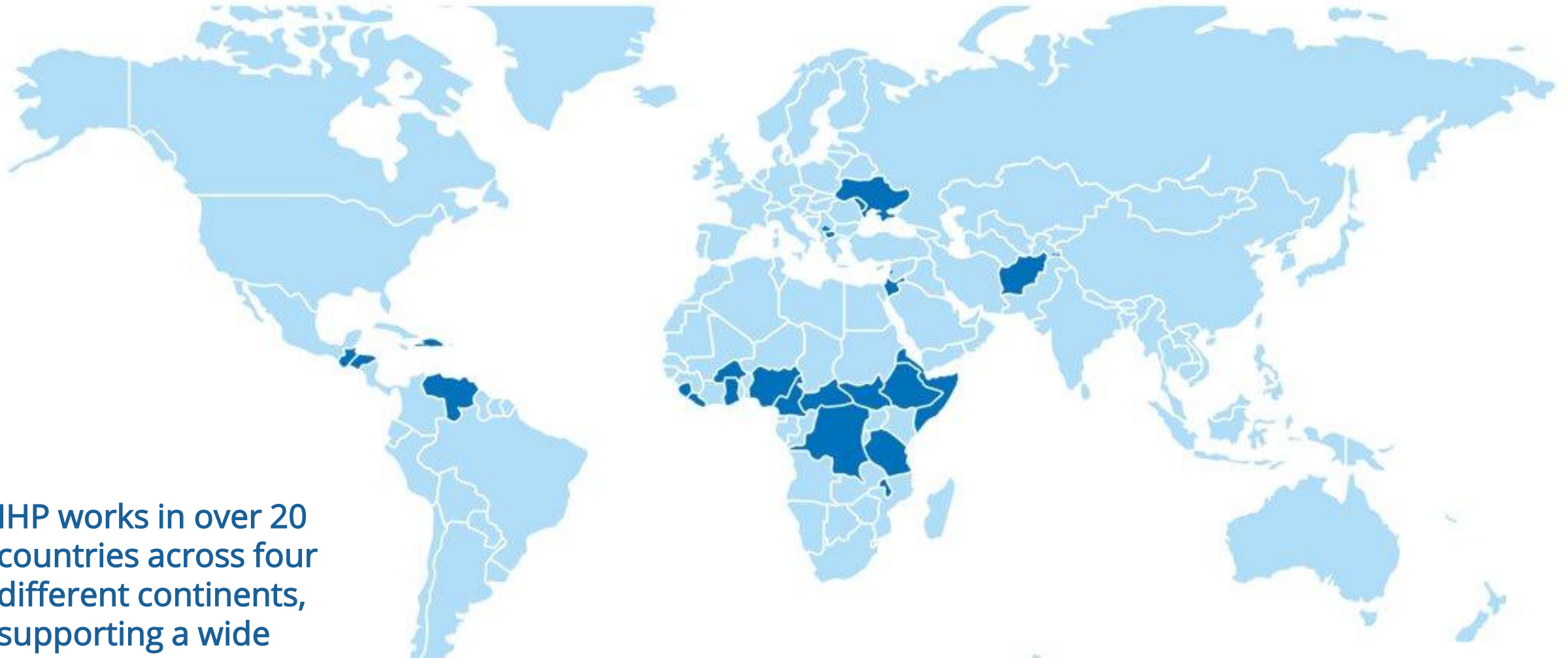

# Board of Directors

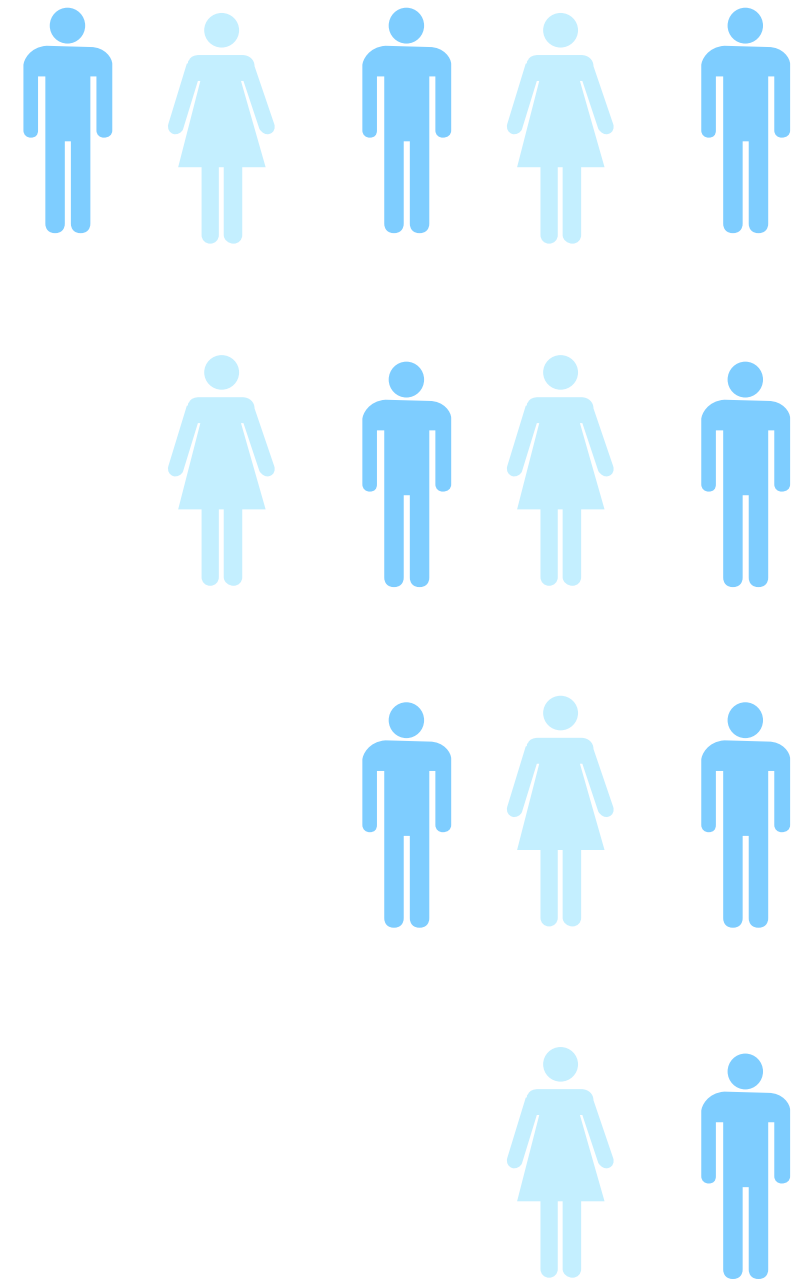
The board of directors of IHP EU currently consists of 3 individuals. The board shall always maintain a minimum of three directors.

**The board currently consists of the following directors:**

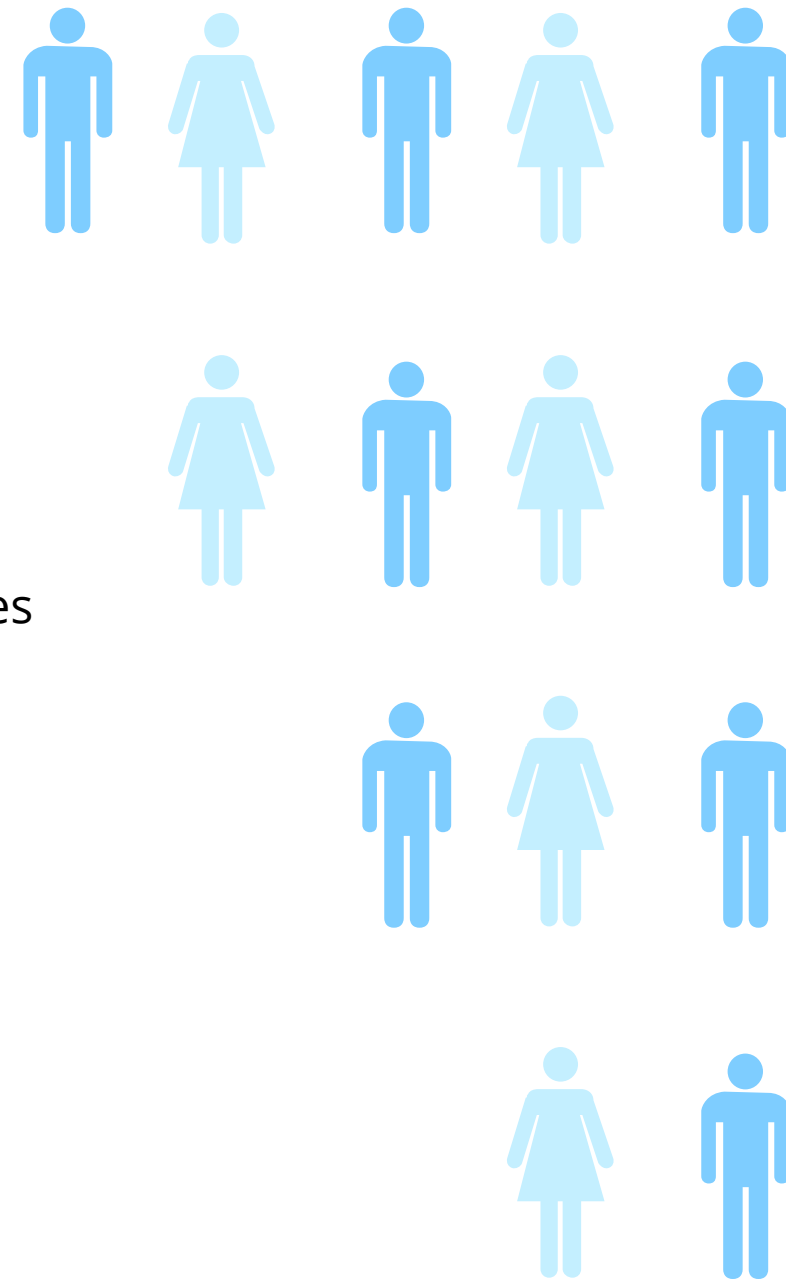
- Chairperson: Christinus Lukkien

# Compensation and Decision Power



The Board lacks individual control over the foundation's assets.

All directors have equal voting power, that being one vote. This ensures that decisions are reached by majority consensus.

Board members volunteer their time and receive no compensation except for reasonable reimbursement for incurred expenses.

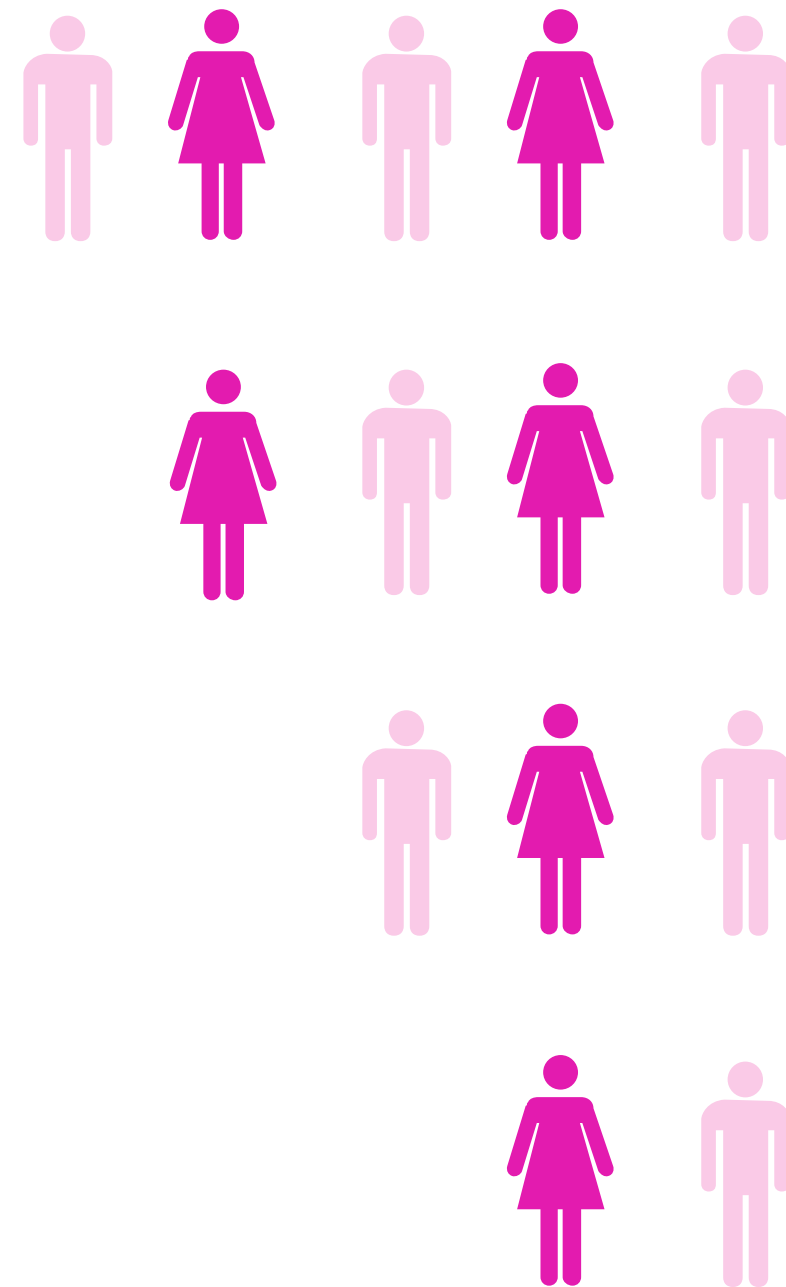




# Financial Administration & Fundraising

Stichting IHP EU is a newly-formed non-profit foundation. The financial administration is currently executed by the founding directors of the foundation. All funds received will be expended in line with the foundation's statutory objectives. This includes funding operational activities to support its work and funding other charitable organisations whose objectives align with the objectives of IHP EU. The directors of IHP EU hold accountability and transparency in the highest regard and will ensure accurate recordkeeping and compliance.

While the foundation is being established, it will receive guidance and administrative support from IHP UK, with regard to ensuring all financial transactions are handled appropriately and compliantly with the relevant regulators.

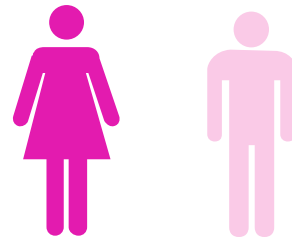
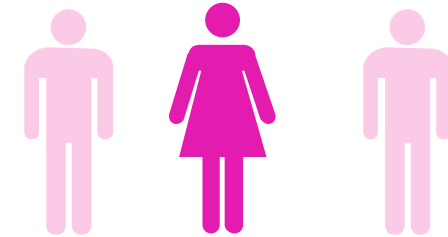
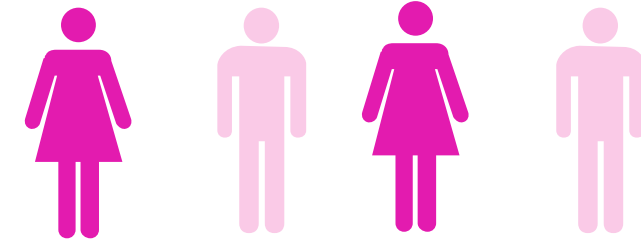
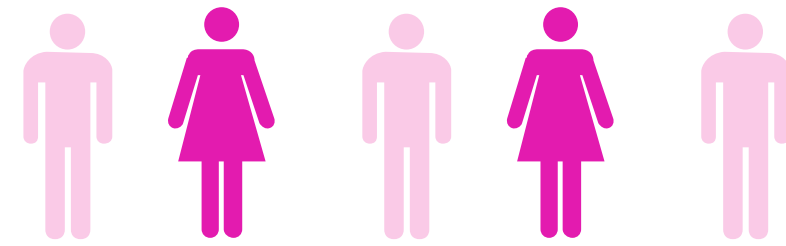
## Budgetary Management

The Treasurer of IHP EU will present the draft financial plans to the board of directors. After a majority approval, the budget is executed. The board of IHP EU will review the progress against the budget every at every board meeting.

The IHP UK finance team will provide guidance and administrative support to the IHP EU board regarding budget setting and monitoring.

## Fundraising

Stichting IHP EU's fundraising activities consist of engaging (pharmaceutical) corporate donors for both medical gift-in-kind and monetary donations, as well as building relationships with and applying for grants from trusts & foundations, institutional donors, and individuals. IHP UK will provide fundraising support to IHP EU.

# Absence of profit

The funds and means of the foundation for the purpose of realisation of its objects will be formed and created from:

- a. subsidies, grants and other contributions;
- b. gifts, inheritances and legacies;
- c. all other acquisitions and gains.

The foundation may only accept inheritances under the benefit of inventory.

The foundation shall not engage in commercial activities or sell products. The foundation may charge fees limited to covering costs and supporting the foundations objectives, which shall not result in a profit and shall be applied exclusively to the achievement of foundations objectives.

# Assignment of fund post-dissolution

Any credit balance of the dissolved foundation will be spent on behalf of a public benefit institution within the meaning of Article 5b paragraph 3 sub a of the Dutch State Tax Act (ANBI) with a similar objective as the objective of the foundation.
