
- Learn from an attorney about ethical practices of savvy clinicians.

Much of what skilled clinicians do can be viewed through a hypnotic lens. Learn to incorporate hypnotic techniques for focused attention to hard to resolve issues including anxiety, depression, somatic concerns, and even performance enhancement. This program will highlight how hypnosis can have a great impact in your therapeutic strategy.
