



MANAGEMENT AGREEMENT ATHLETES FUNDING Fédération québécoise de ski acrobatique

BETWEEN:

AND:

Fédération québécoise de ski acrobatique, a non-profit provincial organization which manage and sanction freestyle skiing competitive programs in Québec, having a business place at **7665 Bd Lacordaire, Montréal, QC, H1S 2A7**, hereby represented by Mrs. Sophie Lafrance, Acting Executive Director, hereby duly authorized,

(hereinafter referred to as the "Federation")

(hereinafter jointly referred to as the "Parties")

AND:

_____, [Company name], a legal entity duly incorporated under the Part 1A of the Quebec Companies Act, having a business place in _____

(hereinafter referred to as the « Sponsor »)

WHEREAS the General Partner, by his good results, has a good potential for visibility in the medias.

WHEREAS the Federation is party to the present sponsorship agreement as the manager of the funds paid by the Sponsor to the General Partner.

WHEREAS the Federation does not intervene in the business relationship between the Sponsor and the General Partner except for the compliance to its rules and regulations.

WHEREAS the General Partner and the Sponsor commit to respect the Federation's rules and regulations, namely those regarding sponsorship and promotion.

WHEREAS the Federation reserves the right to cancel the present agreement and to its sole discretion, to reimburse the Sponsor, in the event that the General Partner or the Sponsor do not respect its rules and regulations.

THE PARTIES AGREE TO THE FOLLOWING:

1. In return for the visibility provided by the General Partner, the Sponsor agrees to:
 - i. Pay to the Federation the sum of _____ dollars (\$ _____) as a sponsorship of the General Partner for **20__-20__**;
 - ii. Draft the cheque to "**Fédération québécoise de ski acrobatique – Fonds des athlètes**".
2. In return for the sponsorship and subject to the approval of the Federation, the General Partner commits to:
 - i. Pay the Federation an administrative fee of thirty dollars (30\$) for each account deposit;
 - ii. Affix the Sponsor's logo on his helmet and/or his skis;
 - iii. Wear his helmet during medals presentation, media interviews and on any circumstances providing visibility to the Sponsor;
 - iv. Mention the Sponsor's name in all communications or during acknowledgments.
3. As the manager of the funds deposited for a sponsorship, the Federation commits to:
 - i. Keep the funds in a bank account for the benefit of the General Partner;
 - ii. Use the funds on deposit for the benefit of the General Partner to pay expenses resulting from the General Partner's participation in the Quebec Team program, and this, as approved by the General Partner;
 - a) Use the funds of the General Partner's to pay expenses previously incurred by the Federation for the benefit of the athlete **or** use the funds to pay directly expenses incurred by the General Partner or any other person designated by the General Partner, as requested by the latter;
 - b) In the event that the Federation should issue a cheque to reimburse expenses to the General Partner or to any other person designated by the General Partner, such cheque will be issued following the submission of a written request for expense reimbursement;
 - iii. Provide the balance of funds available in the General Partner account upon request by the General Partner or at the end of the Federation's fiscal year (May 31st);
 - iv. Carry forward to the following year any amount not used during the current year (May 31st).
4. The Federation will reimburse to the Sponsor funds paid for the benefit of the General Partner under the following terms and conditions:
 - i. If the current agreement is terminated by one of the Parties or if the General Partner retires on his own initiative during the season, the Federation will keep a minimum amount equal to forty percent (40%) of the sponsorship plus five percent (5%) per month as from the beginning of the sponsorship.
 - ii. If the General Partner is evicted from the Quebec Team for breaking the athlete agreement, the Federation will not make **any** reimbursement.
 - iii. At the end of the General Partner's participation to the Quebec Team, whether it is resulting from the General Partner's retirement or the selection to the Canadian Team, it is understood that the Federation will pay to the General Partner the balance of the unused funds less the sums due to the

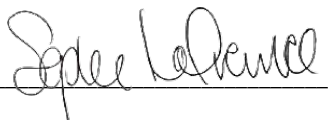


Federation for expenses incurred for the benefit of the General partner's participation to the Quebec Team's program or any other applicable costs.
