YOU AND EACH OF YOU will please take notice that a Petition for Guardianship has been filed for the above named child and a Guardianship Readiness Hearing will take place on Tuesday, the 23<sup>RD</sup> day of SEPTEMBER, 2025 beginning at 11:30AM, in the Muckleshoot Tribal Court of Justice, located on the Muckleshoot Indian Reservation, Auburn, Washington.

The purpose of this hearing is to determine whether the Petition for Guardianship is contested and if so, then setting this case for a Trial to establish a Guardianship for the above named child.

Per Section Title 12 Section 12A.04 of the Muckleshoot Tribal Court, Muckleshoot Child and Family Services shall file a written Guardianship Qualifications Report containing information on the qualifications of the proposed guardian to provide parent care, and abilities to fulfill the requirements in Title 14, Section 14.09.040, and the preparer's recommendations at least ten (10) days prior to the final Guardianship hearing and/or Trial date.

The court will be making a determination that may affect your rights and responsibilities with regard to the above named child. Should you fail to appear at

1 the hearing a default judgment could be entered against you and you could lose your  
2 rights in regard to this child.

3 A facilitated Family Group Meeting will be made available if requested by any  
4 party.

5 All parties are entitled to have legal representation at this hearing at their  
6 own expense, meaning you are solely responsible for any legal fees charged by your  
7 attorney or spokesperson.
