FINDINGS OF FACTS AND CONCLUSIONS OF LAW

1. This matter came before the Court on this 18th day of December 2025 pursuant to Chapter 4.01 of the Muckleshoot Tribal Code.
2. The Court ordered a Notice of Hearing Date Change due to inclement weather.
3. This Court has jurisdiction over the parties and the subject matter.

1 4. Petitioner is the Tribal Prosecutor, acting in his or her official capacity at the direction of Tribal
2 Council Chair or Vice-Chair to obtain an Order for Exclusion on behalf of the Muckleshoot Indian
3 Tribe.
5 5. The reasons stated in the Tribe's Petition for Exclusion constitute adequate grounds for immediate
removal and temporary exclusion.

5 **ORDER**

6 **It is hereby Ordered that:**

7 Respondent is TEMPORARILY Excluded from the Muckleshoot Indian Reservation and any of its
8 land and buildings within the exterior boundaries until this matter can be heard and adjudicated.
9 Territory is all lands and buildings within the exterior boundaries of the Muckleshoot Indian
10 Reservation. Nothing in this order shall restrict the ability of Respondent, if entitled to do so, to
lawfully use licenses, easements, grants, or rights-of-way of record within the territory of the
11 Muckleshoot Indian Tribe. A map has been provided to Respondent with this Order. A map will
12 be provided to the Respondent upon request. Please call the Court at 253-876-3203 to request a copy of
the map.

13 Any and all future hearings involving this Respondent will be conducted by telephone or Zoom.
14 Respondent shall call Court at 253-876-3203 for link or call-in information. Respondent may not
15 enter upon the Reservation to attend court hearings.

16 This matter shall come before the Court for a hearing to determine if a permanent order of
17 exclusion should be entered on **January 22, 2026 at 9:30 a.m.** If the Respondent does not attend, a
default order may be entered.

18 **Other/Exceptions:** _____

19 The terms of this order are effective immediately and shall remain in effect until **January 29, 2026**
20 **at 5 p.m.** unless modified at a later hearing. The order may be dismissed, modified, extended, or
21 made permanent at the next hearing.

22 Any person subjected to any order of the Court under Chapter 4.01 may appeal to the Muckleshoot
Court of Justice of Appeals.

23 **WACIC Data Entry**

24 It is further ordered that the clerk of the court shall forward a copy of this order on or before the next
judicial day to Muckleshoot Police Department and shall enter it in a computer-based criminal
intelligence system available in this state used by law enforcement to list outstanding warrants.
