11 YOU AND EACH OF YOU will please take notice that a Petition for Guardianship  
12 has been filed for the above named child and a Guardianship Fact Finding Hearing will  
13 take place on Tuesday, the 17<sup>TH</sup> day of February, 2026 beginning at 10:00 AM,  
14 in the Muckleshoot Tribal Court of Justice, located on the Muckleshoot Indian  
15 Reservation, Auburn, Washington.

16 The purpose of this hearing is to determine whether the Petition for  
17 Guardianship is contested and if so, then setting this case for a Trial to establish a  
18 Guardianship for the above named child.

19 Per Section Title 12 Section 12A.04 of the Muckleshoot Tribal Court,  
20 Muckleshoot Child and Family Services shall file a written Guardianship Qualifications  
21 Report containing information on the qualifications of the proposed guardian to  
22 provide parent care, and abilities to fulfill the requirements in Title 14, Section  
23 14.09.040, and the preparer's recommendations at least ten (10) days prior to the  
24 final Guardianship hearing and/or Trial date.

25 The court will be making a determination that may affect your rights and  
26 responsibilities with regard to the above named child. Should you fail to appear at  
27 the hearing a default judgment could be entered against you and you could lose your  
28 rights in regard to this child.

29 A facilitated Family Group Meeting will be made available if requested by any  
30 party.

3 attorney or spokesperson.
