THIS MATTER came before the Court this 10th day of March 2026 to review a Sexual Assault Protection Order. The Court now finds and concludes that the Court continues to have jurisdiction over the parties and the subject matter, that all parties received an opportunity to be heard, and that:

8 **1. The Permanent Order of Protection remains in full force and effect, except as modified below, and**

9  **NO CONTACT:** Respondent is **Prohibited** from having any contact with petitioner, including but not  
10 limited to telephone calls, mail, written notes, email, texting, and social media (including but not limited  
to Facebook), directly, indirectly, or through third parties regardless of whether those third parties know  
of the order, except for proper service of court documents.

11  Respondent is **Excluded** from the protected person's residence

12  Respondent is **Restrained** from coming within 500 feet (distance) and from having any contact  
13 with the protected person, in person or through others, by phone, mail, or any means, directly or  
indirectly, except through an attorney, or mailing or delivery by a third party of court documents.

14  Respondent is **Prohibited** from knowingly coming within, or knowingly remaining within, 500 feet  
15 (distance) of the protected person's:  residence  workplace  school, daycare and/or summer camp  
 Muckleshoot Community Center, 17432 SE 392nd St, Auburn, WA 98092.

16  Community contact is permitted.

25  **WACIC Data Entry:** The Court Clerk shall forward a copy of this order  **modifying**  dismissing the  
26 Order of Protection on or before the next judicial day to the King County Sheriff's Office, which shall enter  
it in a computer-based criminal intelligence system available in this state used by law enforcement to list  
outstanding warrants. If the order has been modified, the Court Clerk shall provide parties a new copy of  
the original Order of Protection, with this Order attached and certified.

1 **Service and Clerk's Action:** The Court Clerk shall arrange for service of this order on Respondent. Notice to  
2 Respondent shall be by: personal service mail publication. If diligent attempts to personally serve  
3 Respondent have failed, the Clerk of the Court shall publish notice at the next available opportunity. A copy  
4 shall also be sent to Muckleshoot Police Department \_\_\_\_\_ Police Department **where**  
5 **respondent lives** which shall personally serve respondent with a copy of this order and shall promptly complete  
6 and return to this Court proof of service. The service packet shall include a copy of the petition, temporary  
7 order, notice of hearing, and any supporting declarations or other materials. Service on Respondent not  
8 required because Respondent order is maintained, unchanged, and Respondent is in default.

Protected Person may be served via email to MCFS. MCFS will ensure that all relevant entities such as the  
Protected Person's school receive a copy.

9 This order shall be accorded full faith and credit by the courts of all other States, Indian Tribes, and territories  
10 pursuant to 18 U.S. Code § 2265, MTC § 4.03.190, RCW § 13.34.240, and Washington Civil Rule 82.5(c).
