15 YOU AND EACH OF YOU are hereby notified that a REQUEST FOR PRELIMINARY INQUIRY
16 has been filed in the Muckleshoot Tribal Court and a PRELIMINARY INQUIRY HEARING will
17 be held on TUESDAY, June 9th, 2026 at 2:00pm. in the above-titled court, located at the
18 Muckleshoot Legal Building, 39015 172nd Avenue SE, Auburn, Washington 98092, to
19 determine;

- 20 1.) The tribal status of the youth;
- 21 2.) Whether probable cause exists to believe that the youth is YOUTH IN NEED OF
22 CARE, and tribal court supervision.
- 23 3.) Whether out of home placement of the youth is necessary and
- 24 4.) Any other action necessary for the youth best interest pending further
25 proceedings.

26 The parents, guardian and custodian of the youth are each entitled to have
27 someone represent them at this hearing at their own expense-meaning that they will
28 be solely responsible for any fees charged by the person.

29 The Court will be making a determination at the hearing which may affect the
30 party's rights and responsibilities in regard to the named child.

31 If you fail to appear, a default judgment could be entered against you and your
32 rights in regard to the child can be affected.
