Each collection includes homes in different destinations — for example, a farmhouse in Tuscany, a villa in the South of France, a townhouse in Mallorca, and a chalet in the Alps. Owners can holiday across all properties throughout the year.

The concept combines the stability and long-term benefits of ownership with the flexibility of travel — all without the administrative burden of managing property abroad.

Full-Service Management from Start to Stay

What sets August apart is its end-to-end service.



August handles everything: from sourcing and purchasing the properties to managing renovations, design, and local compliance.

Once the homes are operational, August continues to oversee maintenance, housekeeping, and guest services. Owners don't need to worry about plumbing issues, utility bills, or hiring local contractors — everything is taken care of. Support is available onsite during stays, and bookings are managed through a central platform.

The properties themselves are thoughtfully designed, with a focus on comfort, quality, and local character. Each one is chosen for its location, charm, and connection to the surrounding community — avoiding the generic feel of short-term rentals.
