DEFENDER OF THE BLUE
ATTORNEYS FOR LAW ENFORCEMENT

THE ASSOCIATION IS ACCOUNTABLE TO ITS MEMBERS TO ENSURE THAT MANDATORY DUES ARE USED FOR THE NECESSARY EXPENSES TO ADMINISTER THE COLLECTIVE BARGAINING AGREEMENT. THIS INCLUDES THE DISSEMINATION OF INFORMATION TO MEMBERS WHO ATTEND THE EXECUTIVE BOARD BUSINESS MEETINGS. MEMBERS MUST ATTEND TRAINING SESSIONS AND BUSINESS MEETINGS WHEN THE ASSOCIATION IS PROVIDING THEM WITH DIRECT OR REIMBURSED BENEFITS SUCH AS MILEAGE AND LODGING ACCOMMODATIONS. IF A MEMBER IS RECEIVING REIMBURSED BENEFITS, AND A TRAINING SESSION OR BUSINESS MEETING MUST BE MISSED, THE MEMBER IS RESPONSIBLE TO NOTIFY THEIR DISTRICT OR REGIONAL REPRESENTATIVE OF THE REASON. MEMBERS NOT COMPLYING WITH THIS POLICY MAY BE DENIED EXPENSE REIMBURSEMENT.
