## **Privacy Policy**

The website ("Site") for Terazo Fintech LLP ("Terazo", "We", "Our", "Us" or "LLP") was created to provide an intermediary technology platform for certain other persons to independently review and invest in private placement offerings (the "Services").

The privacy of our Site visitors ("you," "your," or "user") is important to us, and in order to protect your personal information, We have implemented the following Privacy Policy with provisions that apply to the collection of data by Terazo, its subsidiaries, and its affiliates.

Our Privacy Policy discloses the type and nature of information We collect and how We use it, as well as the choices you can make about the way your information is collected and used. We also explain how any requests for personal or personally identifiable information will be used. ## **Information We Collect**

We are required by law, regulation or securities reasons to ask for certain personal and financial information in order to provide our Services to you. Terazo makes commercially reasonable best efforts to maintain the confidentiality, integrity and security of our clients' personal information.

You may choose to provide additional information during subsequent visits to the Site, but keep in mind that some of this information will be required if you wish to partake in the Services.

In general, the type of information We collect includes, but is not limited to:

- Contact information and personal details, such as your name, residential, business and postal addresses, telephone number, email address, and family details such as name of your spouse, partner or children;
- Profile information, such as the username and password you establish with the Services;
- Demographic details, such as date of birth, country of citizenship and/or country of residence, marital status;
- Government-issued identification (to the extent permitted under applicable law), such as a national identification number (e.g., tax identification number, or passport number), state or local identification number (e.g., a Driver's License or other government-issued identification number), a copy of your government-issued identification card and related government issued photographs;
- Information about your investment experience and preferences, such as investment objectives, investment experience, liquidity needs, and risk tolerance;
- Financial Account and payment Information, such as your tax returns and bank accounts you may use to source your investment funds, other related payment information and the cryptocurrency wallet addresses;
- Feedback and correspondence, such as information you provide when you request information from us, receive customer support, or otherwise correspond with us, including by interacting with our pages on social networking online sites or services;
- Marketing information, such as your preferences for receiving marketing communications and details about how you engage with our marketing communications;
- Transaction Information: Information about the transactions you make on our Services, such as the name of the recipient, your name, the amount, and/or timestamp.
- Other information you choose to provide.

When visiting our website, We also store every instance of access in a log file and therefore, the following Data are stored in this process:

- Computer or mobile device information
- Website from which our domain is accessed and website usage information
- Operating system of your computer
- Country from which our website is accessed
- Name of your internet provider
- Name and URL of the Data accessed
- Date and time of access
- IP address of the accessing computer

Keeping client information secure, and using it only as our Users want us to, are matters of principle for all of us at Terazó. With this in mind, here is our commitment to each and every User:

- Except as you may otherwise expressly approve, We will limit the collection and use of client and user information to what We believe would be useful to service your accounts, administer our business, or to tell you about our Services;

- We will restrict employee access to client and user information to those who need to know in order to provide Services to you;
- We will educate our employees according to our internal policies to reinforce the importance of confidentiality and client and user privacy;
- We will maintain commercially reasonable and customary security standards and procedures to protect information about you; and
- We will respond quickly to your request to correct inaccurate information.

Terazo will also gather the names and email addresses of users who contact us through the Site with questions about our platform.

Any data including, but not limited to, your name, address, telephone number, e-mail address and other information submitted to Terazo during identity verification process is handled by Terazo and our third-party software/services providers. Terazo is also required to retain personally identifiable information (PII) submitted as part of that process in terms of rules and regulations prescribed by International Financial Services Centres Authority (IFSCA).

### **Right to Withdraw Consent**

You may withdraw your consent to the processing of your personal data at any time by submitting a request to [info@terazo.network](mailto:info@terazo.network). Upon receipt, the Company will cease processing activities that rely exclusively on your consent, unless another lawful basis applies under the GDPR or other applicable data protection laws. Withdrawal does not affect the lawfulness of processing carried out prior to such withdrawal, and further processing may occur where required for compliance with legal obligations or for the establishment, exercise, or defence of legal claims.

### **Data Protection Officer (DPO)**

### **How and Why We Gather Information**

When you register for an account for the Services or at any later time, We collect certain personal information from you to open an account, transact business, communicate with you, verify your identity and fulfil legal and regulatory requirements. We call this your “Profile.” From time to time, We may request additional information (e.g., through forms and surveys) to help us further assess your needs and preferences.

If you choose to provide such information, during registration or otherwise, you are giving Terazo the permission to use and store it consistent with this Privacy Policy. We may also obtain your personal information from your transactions with us or other Users through the

Services. If We combine or associate information from other sources with personal information that you provide directly to us through or in connection with the Services, We will treat the combined information as personal information in accordance with this Privacy Policy.

## **Cookies**

We are Terazo Fintech LLP (referred to as the “Terazo”, “We”, “Us” or “Our”).

Our cookie policy (“Cookie Policy”) explains how and why We use cookies on our websites.

By continuing to use our website and/or mobile application without changing your settings, you consent to our use of cookies as set out in this Cookie Policy. If you do not agree to our use of cookies as set out in this Cookie Policy, you should disable or delete the cookies associated with the websites and/or mobile application by changing the setting on the web browser on your device accordingly.

We may from time to time amend the Cookie Policy. Such changes will be published here and effective upon publication. Please check the Cookie Policy regularly for updated information/version. Your continued access and/or use of our website, our mobile application, our products and/or our services will constitute your agreement to the revised Cookie Policy.

Cookies are small files which are stored on your hard drive by your internet browser software while you are browsing.

## **How We use cookies**

We use cookies to:

- (a) manage the signing up process and general administration when you create an account with us;
- (b) remember your user details for future correspondence when you submit data through a form;
- (c) remember your preferences when viewing our websites or using our mobile website;
- (d) to remember when you are logged in to your account, which prevents you from having to log in every single time you visit a new page;
- (e) ensure that your orders are remembered between pages so that We can process them properly;

- (g) collect statistical information about users of our websites or mobile application (for example, time spent on each page and which links our users choose to click); and

### **Sharing Your Information**

We may allow you to share certain information with other Users of the Services. If you indicate an interest in making an investment through the Services, such as indicating an interest to buy tokens using our platform, We will notify the party or parties offering the investment of your interest and may notify other Users with whom you have chosen to share information. By indicating an interest in an investment and/or sharing your Profile with other Users, you consent to this disclosure of your information. We may also collect and store information, which could include Non-Personally Identifiable Information or Personally Identifiable Information, locally on your computer or device using mechanisms such as browser web storage or application data caches.

### **Social Media Services**

We may allow logging in to the Website using social media services such as Google or Facebook. These services will authenticate your identity and provide you the option to share certain personal information with us such as your name and email address to pre-populate our sign up form.

Our Website may also include social sharing features for common social networks. These features are interactive mini-programs and may collect your IP address and the page you are visiting on our site. They may set a cookie to enable the feature to function properly. When you register as an investor, you are also consenting to Terazo's SMS Communications program, to receive text messages sent by an automatic telephone dialling system and acknowledge that data usage charges may apply by your cell phone company. You may receive text messages regarding 2 step verification, system notifications, investment opportunity updates, and special offers and promotions.

We may also send you responses to emails you send us, if appropriate. From time to time, We will also send user surveys, requests for user feedback regarding user experience and Site operations, or marketing offers from us or from us on behalf of our marketing partners. Completing these surveys, answering requests for feedback, or accepting any offer is voluntary.

Terazo will never send you an email asking you for your login information. In general, you can protect yourself against phishing by never providing personal or login information via a link contained in an email; instead, go the website directly.
