

Credits and Pricing Tiers

Each subscription tier includes a monthly credit balance at a set per-credit rate. Higher tiers unlock lower per-credit costs. Credits can be used across any package combination.

Credit Policy

- Unused credits carry forward month-to-month as long as your subscription is active. Each batch of credits is valid for 12 months from issuance and applied oldest-first. **Credits are forfeited upon cancellation.**
- If you exceed your monthly credit balance, additional credits are billed at your current tier's per-credit rate. Your account **stays fully operational** with no interruptions to report ordering.
- Tiers can be adjusted up or down each billing period. Notify us before your next billing date and we will make the change. There is **no penalty for switching tiers.**
- **Pass-through fees:** court filing fees and physical courthouse retrieval costs are billed separately at cost when investigators conduct live searches. These are disclosed upfront and are not included in subscription or credit pricing.

Subscription clients can add any of the following searches to a custom package. Credits are drawn from your monthly balance, giving you the flexibility to build a screening program tailored to your specific due diligence needs.

Subscription Pricing & Credits

- **How do credits work?**

Credits are the currency of your subscription. Each month you receive a set number based on your tier, which you use to order investigations. Each package, Instant, Advanced, and Deep Dive, costs a different amount of credits, with deeper investigations consuming more.

- **What's the difference between Instant, Advanced, and Deep Dive?**

Instant reports are fully automated and return results in under 2 minutes, great for high-volume screening and low-risk scenarios. Advanced and Deep Dive are conducted by our licensed investigators and return within an estimated 2 to 3 business days. Advanced covers the subject's current jurisdiction with a 10-year lookback. Deep Dive goes further, covering up to three jurisdictions, a 20-year lookback, multiple name variations, and all case statuses.

- **Can I upgrade a report after ordering it?**

Yes. You only pay the credit difference to move from Instant to Advanced, or Advanced to Deep Dive, not the full cost of a new report.

- **Do credits expire?**

Credits roll over month-to-month as long as your subscription is active. Each batch is valid for 12 months and applied oldest-first.

- **What if I use all my credits before the month ends?**

You won't lose access. Additional credits are billed at your current tier's per-credit rate so you can keep ordering without interruption.

- **Is there a long-term contract?**

No. Business Screen is month-to-month with no annual commitment and no multi-year lock-in. Cancel anytime, though unused credits are forfeited upon cancellation. Consult sales if you are interested in a year or multi-year contract.

- **Can I change my tier month-to-month?**

Yes. Scale up or down each billing period based on your expected volume. Just let us know before your next billing date. There is no penalty for switching.

- **Are there setup or per-user fees?**

No setup fees, no seat charges. Add as many users as you need at no additional cost.

- **Can I pay per report instead of subscribing?**

Yes. Our Pay-As-You-Go option lets you order reports individually with no monthly commitment, a good fit for low or unpredictable volume. Reach out to our sales team to learn more.

- **Do you offer volume or annual pricing?**

Yes. Higher-volume clients can structure annual agreements with discounted per-credit rates and flexible payment terms, upfront or quarterly. Reach out to discuss what fits your program.
