PORTABILITY REGULATIONS

Portability regulations pursuant to CFR 982.353 “Where a family can lease a unit with tenant-based assistance” for applicants who attend a briefing and received their initial voucher are as follows:

“Resident applicants” 982.353(b) (a person who applies for housing assistance and lives in the Jurisdiction where they are receiving the voucher) are eligible for initial portability.

“Non-resident applicants” 982.353(c)(2)(i) (a person who applies for housing assistance and lives outside the Jurisdiction where they are receiving the voucher) may lease a unit anywhere within the Jurisdiction of the initial PHA but the family does not have the right to portability. A non-resident applicant may be eligible for portability if they meet the requirements for portability after the first 12-month period of utilization within the initial Jurisdiction.

You may utilize your voucher in the City of Oil City or any of the surrounding areas of Venango County, excluding The City of Franklin. If you are interested in residing within The City of Franklin, please contact that Housing Authority to apply.

We trust this provides the clarification necessary for you to successfully utilize your voucher to secure assisted housing.

IMPORTANT REMINDER NOTICE

SECTION 8 HOUSING CHOICE VOUCHER PROGRAM

THE HUD BUDGET HAS BEEN CUT ACROSS THE NATION. HUD IS ENCOURAGING ALL HOUSING AUTHORITIES TO STRICTLY ENFORCE THE REGULATIONS IN AN EFFORT TO SAVE MONEY. THIS IS A REMINDER TO ALL CLIENTS THAT:

- 1. YOU MUST REPORT ALL CHANGES IN INCOME WITHIN 10 DAYS.**
- 2. YOU CANNOT LET ANYONE MOVE INTO YOUR HOME WITHOUT PRIOR APPROVAL FROM THE OIL CITY HOUSING AUTHORITY AND THE LANDLORD.**
- 3. NO PERSON, OTHER THAN THE AUTHORIZED HOUSEHOLD MEMEBERS, CAN USE THE ASSISTED UNIT ADDRESS OCCUPIED BY THE HEAD OF HOUSEHOLD AS THEIR ADDRESS FOR THE PURPOSE OF, BUT NOT LIMITED TOO, RECEIVING ANY MAIL, OBTAINING A DRIVER'S LICENSE/PHOTO ID, FILING FOR FEDERAL, STATE OR LOCAL RELATED BENEFITS, TAX REFUNDS, FOR EMPLOYMENT PURPOSES OR FOR ANY PURPOSE WHATSOEVER.**
- 4. IF ANY UTILITY SERVICE IS TERMINATED, THE HOME NO LONGER MEETS THE HOUSING QUALITY STANDARDS INSPECTION REQUIREMENTS.**
- 5. HOUSEHOLD MEMBERS CANNOT ENGAGE IN ANY DRUG-RELATED CRIMINAL ACTIVITY OR VIOLENT ACTIVITY.**

FAILURE TO ABIDE BY THE ABOVE RULES IS A VIOLATION OF YOUR FAMILY OBLIGATION(S) AND IS A REASON FOR IMMEDIATE TERMINATION OF YOU HOUSING ASSISTANCE PAYMENT CONTRACT.
